Station J. Station K. in Block III, Opoiti Survey District, south-westerly, north-easterly, and generally westerly along the boundary of Lot 1, D.P. 1381, to its westernmost corner, northerly along the western boundary of the said Lot 1, crossing State Highway No. 36, to and along that boundary and its production to the middle of the Hangaroa River, up the middle of that river to a point in line with the south-eastern boundary of part Lot 3a, D.P. 501, in Block XIV, Hangaroa Survey District, to and along that boundary, the south-western boundary of the said lot, the south-western boundary of Lot 2, D.P. 2296, the south-western, southern, and western boundaries of Section 1, Block X, Hangaroa Survey District, and the production of the last-mentioned boundary across Ruakaka Road to its eastern side, along that roadside, the eastern and northern boundaries of Section 10, Block IX, Hangaroa Survey District, the north-eastern side of Ruakaka Road and its production to and along the middle of Gisborne-Waikaremoana Road to a point in line with the south-eastern boundary of Section 1, Block VIII, Tuahu Survey District, to and along that boundary, the southern boundary of Lot 20, D.P. 1950, the north-eastern boundary of Lot 21, D.P. 1951, and its production across Papuni-Ruakituri Road to and along the generally north-eastern boundaries of the last-mentioned lot, the western boundary of Lot 19, D.P. 1950, the southern boundary of Lot 2, L.T. 618, the north-eastern and western boundaries of part Lot 18, D.P. 1970 (crossing a public road), the western boundary of part Lot 2, L.T. 619, to its intersection in Block II, Tuahu Survey District, with a right line between Trig. Station Puketapu in Block II, Tuahu Survey District, and Trig. Station Maungapohatu (2126) in Block XII, Ruatahuna Survey District; thence north-westerly along that right line to Trig. Station Maungapohatu (2126), being a point on the south-eastern watershed of the Rangitaiki and Whakatane Rivers; thence south-westerly generally along that watershed to the northernmost corner of Pohokura No. 1 Block in Block IV, Runanga Survey District, along the western boundary of Pohokura No. 1 to its south-western corner in Block XIII, Mangahopai West Survey District; thence south-easterly generally along the southern boundary of Pohokura No. 1, the generally western boundaries of Tatara-a-kina No. 11 Block and its production to the middle of the Mohaka River, down the middle of that river to a point in line with the north-eastern boundary of part Section 6, Block V, Waitara Survey District, to and along that boundary and the north-eastern boundary of part Section 3, Block XI, Waitara Survey District, and its production to the middle of the Waikari River, down the middle of that river to the sea coast in Block IX, Moeangiangi Survey District; thence easterly generally along the sea coast, including part Section 2, Block V, and Section 1, Block VI, Clyde Survey District, to the point of commencement, excluding therefrom the Borough of Wairoa, as described in *Gazette*, 1909, p. 2379, and including Portland Island.

#### BOUNDARIES OF WAIU RIDING OF COUNTY OF WAIROA

ALL that area in the Gisborne, Hawke's Bay, and South Auckland Land Districts, Wairoa County, bounded by a line commencing at the south-eastern corner of Lot 1, D.P. 3807 (Hawke's Bay Registry), and being a point on the sea coast, proceeding generally easterly along the western, southern, and eastern boundaries of part Section 2, Block V, Clyde Survey District, to the northernmost point of that section, being also a point on the Wairoa Borough boundary; thence northerly and westerly generally along the borough boundary, as described in *New Zealand Gazette*, 1909, p. 2379, to the south-western boundary of Lot 4, D.P. 7212; thence north-westerly along that boundary produced to the middle of the Wairoa River; thence north-westerly generally up the middle of the Wairoa River to its junction with the Waiau River, up the middle of the Waiau River to its junction with the Tutakuri River; thence westerly generally up the middle of that river to a point in line with the south-western boundary of part Section 3, to and along that boundary, the south-western boundary of Section 4, and the south-western boundary of Section 5, Block XIV, Taramarama Survey District, the south-eastern boundary of Tutakuri 1c 6, across a public road and again along that boundary, to and across that public road to its northern side, along that northern side to the southernmost point of part Section 6, Block XIV, Taramarama Survey District, across that public road to and along the south-eastern boundaries of Sections 7 and 8, Block XIV, Taramarama Survey District, along the south-western boundary of the said Section 8, across a public road, to and along the south-western and western boundaries of Section 8, Block XIII, Taramarama Survey District, the south-western boundary of Section 13, Block XIII, Taramarama Survey District, and its production to the middle of the Waiau River, up the middle of that river to a point in line with the eastern boundary of Block XIII, Waiau Survey District, to and along that boundary, crossing two intervening public roads, along the eastern boundary of Block VI, Waiau Survey District, across a public road and again along that boundary to a point on the southern boundary of S.G.R. 108, Block XXVII, Waiau Survey District, along the southern and western boundaries of S.G.R. 108, the northern and north-western boundaries of Section 4, Block V, Waiau Survey District, to the easternmost corner of Waiau West Survey District, along the northern boundary of that survey district and its production to the middle of the Waiau River, up the middle of that river to a point in line with the north-eastern boundary of Heruiwi 4c, to and along that boundary and the north-eastern boundary of Heruiwi 4b to the production south-westerly of a right line between the northernmost point on the shore of Lake Waikaremoana and a point one hundred and eighty (180) chains due north of Trig. Station C. 2, Maungataniwha; thence southerly generally along that line to the boundary of the Wairoa County, hereinbefore described, along that county boundary to a point in line with the middle of the Te Hoe River; thence south-easterly generally up the middle of that river to a point in line with the northern boundary of Section 1, Block IX, Waitara Survey District, to and along that boundary, the northern boundary of Section 1, Block XXI, the north-western and northern boundaries of part Section 1 and Section 2, Block XXII, Mangahopai Survey District, the north-eastern boundary of the last-mentioned Section 2, and the north-eastern boundaries of Rotokakarangu 2c, 2a, and part 1, again along the north-eastern and eastern boundaries of the said 2a and its production to the middle of the Mohaka River, down the middle of that river to a point in line with the north-western boundary of Mohaka A. 1, to and along the north-western and northern boundaries of the said A. 1, across a public road to and along the northern boundaries of part Mohaka B. 29 and Mohaka A. 3, the northern and north-eastern boundaries of Section 1, Block VI, Waihua Survey District, and the production of the last-mentioned boundary to the middle of the Waihua River, down the middle of that river to the sea coast, and along the sea coast to the point of commencement, excluding therefrom the Borough of Wairoa, as described in *Gazette*, 1909, p. 2379.

#### BOUNDARIES OF WAIKAREMOANA RIDING OF COUNTY OF WAIROA

ALL that land in the Gisborne and South Auckland Land Districts, Wairoa County, bounded by a line commencing at a point on the Waiau Riding, being the junction of the middle lines of the Waiau and Wairoa Rivers, Block XVI, Taramarama Survey District, and proceeding generally northerly up the middle of the Wairoa River to its junction with the Mangaaruhe River, up the middle of that river to a point in line with the eastern boundary of Section 2, Block III, Taramarama Survey District, to and along that boundary, across a public road to its northern side, along that roadside, being the south-eastern and eastern boundaries of Section 1, Block XVII, Tuahu Survey District, to the south-western boundary of Paraumu Block, across a public road to and along the south-western and south-eastern boundaries of that block to the southernmost corner of
