

Waianuanu, at the easternmost corner of Block XVI, Wairere Survey District; thence north-westerly generally along the generally north-eastern boundaries of part Okauia 1, Maurihiro A. and B., Waiharakeke East part 5, 1A, 1C 2B 2, and 1C 1A, and part Section 20, Block III, Wairere Survey District, shown on D.P. 28359, along a right line across Thompsons Track to and along the generally north-eastern boundaries of part Section 20, aforesaid (D.P. 4110), another part Section 20 (D.P. 26605), another part Section 20 (State forest, *New Zealand Gazette*, 1955, page 1892), along the eastern side of a public road to and along the generally north-eastern boundary of Lot 5, D.P. 25781, to its northernmost point; thence north-westerly along the eastern boundary of the original Aroha Block, shown on M.L. 3062, being through State forest in Block X, Aongatete Survey District, and Blocks VII and XI, Katikati Survey District, to the north-western boundary of Katikati Survey District; thence south-westerly along that boundary to Trig. S. 6845, Lots 5 and 4, D.P. 28257, and part Section 5, Block I, Katikati North Survey District, the south-eastern and north-eastern boundaries of Lot 2, D.P. *Revoking a Proclamation Declaring an Area in the Hawke's Bay Acclimatisation District to be a Wildlife Refuge*

A PROCLAMATION

PURSUANT to section 14 of the Wildlife Act 1953, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Internal Affairs and the Minister of Lands (being the Minister charged with the administration of the department of State having the control of the land of the Crown affected by this Proclamation), hereby revoke the Proclamation issued on the 30th day of January 1959\*, declaring an area of land in the Clive Survey District, in the Hawke's Bay Acclimatisation District, to be a wildlife refuge for the purposes of the Wildlife Act 1953; as shown on plan marked I.A. 52/304 deposited in the Head Office, Department of Internal Affairs, Wellington, and thereon edged red.

A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare that the land described in the First Schedule hereto is hereby taken and that the land described in the Second Schedule hereto is hereby taken, together with and subject to the restrictions and easements set out in the said Second Schedule as far as they relate to the pieces of land concerned, for the purpose of constructing a regional road within the meaning of the Auckland Regional Authority Act 1963, and shall vest in the Auckland Regional Authority as from the date hereinafter mentioned; and I also declare that this Proclamation shall take effect on and after the 1st day of September 1969.
