ORDER

1. This order shall come into force on 1 October 1969. 2. The area described in the Schedule hereto is hereby excluded from the County of Southland and included in the City of Invercargill.

3. The alteration of the boundaries of the said county and the said city, hereinbefore made, shall be deemed to have been effected under the Municipal Corporations Act 1954.
