PURSUANT to the Agricultural Pests Destruction Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

1. (1) This order may be cited as the Union of Mandeville, Pukerau, and Glencoe Pest Destruction Districts Declaration 1969.

(2) This order shall come into force on the day after the date of its notification in the Gazette.

2. The boundaries of the Mandeville Pest Destruction District (which was constituted by Order in Council on the 1st day of December 1954\*), the Pukerau Pest Destruction District (which was constituted by Order in Council on the 3rd day of September 1941†), and the Glencoe Pest Destruction District (which was constituted by Order in Council on the 3rd day of October 1947‡) are hereby declared united to form one district having the name Eastern Southland Pest Destruction District, the boundaries of which shall be those specified in the Schedule hereto; and it is hereby further declared that the basis on which the Board for the said district shall first levy its general rate shall be the acreage of the land occupied by the ratepayer.
