NOTICE OF INTENTION TO TAKE LAND AND OF PROPOSAL TO STOP ROAD

NOTICE is hereby given that the Hobson County Council proposes, under the provisions of the Public Works Act 1928 and the Counties Act 1956, to execute a certain public work, namely, the realignment of a road within the County of Hobson; and, for the purposes of such public work, the lands described in the First Schedule hereto are required to be taken, and it is proposed to stop those portions of road described in the Second Schedule hereto and to take the lands described in the Third Schedule hereto, as severance. And notice is hereby given that a plan of the lands so required to be taken and the road to be stopped is deposited in the public office of the clerk of the Council, situated in Dargaville, and is there open for inspection to all persons during ordinary office hours; that all persons affected by the taking of the said lands or the proposed stopping of unused road should, if they have any objection to the taking of the said lands (not being an objection to the amount or payment of compensation) or to the proposed stopping of unused road, set forth the same, in writing, and send such writing, within 40 days from the first publication of this notice, to the County Clerk, at the County Office, Dargaville; and that, if any objection is made in accordance with this notice, a public hearing of objection will be held, unless the objector otherwise requires, and each objector will be advised of the time and place of hearing.

The land to be taken is for Arapohue Main Road.
