"That, in pursuance and exercise of the powers vested in it in that behalf by the Municipal Corporations Act 1954 and amendments, the Local Authorities Loans Act 1956 and amendment, and regulations thereunder, and of all other powers thereunto enabling it, the Auckland City Council hereby resolves as follows:

"That, for the purpose of providing interest and other charges on a loan of thirty-nine thousand nine hundred dollars (\$39,900) to be known as the Redemption Loan No. 55, 1969, \$39,900, which amount is proposed to be raised by the Auckland City Council under the above-mentioned Acts for the purpose of repaying on maturity that portion of the Victoria Street Parking Building Additional Loan 1961, of \$307,200, which matures on 1 November 1969, the said Auckland City Council hereby makes and levies a special rate of point nought nought nine six (.0096) of 1c in the dollar (\$) on the rateable value (on the basis of the annual value) of all rateable property (of Auckland City) comprising the whole of the City of Auckland; and that the said special rate shall be an annual-recurring rate during the currency of such loan, and shall be payable yearly on the 1st day of June in each and every year during the currency of the said loan or until the loan is fully paid off."
