

Licences Issued under the Animal Remedies Act 1967 (Notice No. Ag. 10518)

PURSUANT to section 21 (6) of the Animal Remedies Act 1967, the Registrar hereby gives notice that licences have been issued as set out in the Schedules hereto.

Those in Schedule I are subject to no conditions.

Those in Schedule II are subject to the conditions:

1. That they are not sold to any person other than a veterinary surgeon or a dealer, or otherwise than pursuant to the prescription of a veterinary surgeon.

2. That they are not used otherwise than by or under the supervision of a veterinary surgeon.

Those in Schedule III relate to changes of name of licensed remedies.
