

of Section 28, Block IX, Omapere Survey District; thence to and along that eastern boundary to the Horeke-Okaihau Road, along a right line across that road to the easternmost corner of Section 3, Block IX, aforesaid, and along the generally eastern and northern boundaries of Section 3 and the northern boundary of Section 2, Block IX, aforesaid, to and along the generally north-eastern side of the public road forming the south-western boundary of Section 21, Block V, Omapere Survey District, to and along the western boundaries of Section 21, aforesaid, and Allotment 63, Okaihau Parish, and the production of the last-mentioned boundary across a public road to the southern boundary of Allotment 62; thence along the southern, western, and north-western boundaries of that allotment to and along the south-western boundary of Allotment 41, crossing the intervening public road, along the south-western and north-western boundaries of Allotment 40, the aforesaid allotments being of Okaihau Parish, to and along the south-western boundary of Whakanekeneke A. 1, crossing the intervening public road and railway land, and along the production of the last-mentioned boundary to the middle of the Whakanekeneke River; thence down the middle of that river to and up the middle of the Waipapa River to and up the middle of the Pukatea Stream in Block XIII, Kaeo Survey District, to and up the middle of the branch of that stream which intersects the south-western boundary of Section 3, Block XIV, Kaeo Survey District, to and along the south-western and south-eastern boundaries of that section, and continuing along the north-western boundary of Section 8, Block XIV, aforesaid, and the north-western boundaries of Sections 1s and 4s, Puketū Settlement, along the end of the intervening public road, to Waiare Road; thence along a right line to Manginangina Trig. in Block XV, Kaeo Survey District, and along the southern boundary of Manginangina or Motukauri Block and the production of that southern boundary to and north-easterly along the south-eastern boundary of Section 18, Block XV, aforesaid, along the south-western and eastern boundaries of Section 45, Block XII, Kaeo Survey District, and along the south-western and western sides of the public road forming the south-western boundaries of Sections 28 and 27 and the western boundary of an area of Crown land to the northern end of the roadside bearing $354^{\circ} 53'$, distance 1527.1 links, shown on S.O. Plan 20186; thence along the production of the last-mentioned roadside, across another public road to and easterly along the generally southern boundary of Section 30, along the southern and eastern boundaries of Section 32, all the said sections being of Block XII, aforesaid, along the southern boundaries of old land claim 25 and Section 4, Block VIII, Kaeo Survey District, and along the southern and eastern boundaries of Section 3, Block VIII, aforesaid, to and along the generally southern boundary of old land claim 19, crossing and recrossing State Highway No. 10, to and along the southern and eastern boundaries of Section 4, Block II, Kerikeri Survey District, and along the south-western boundary of Lot 4, D.P. 41103, along a right line across Otaha Road to and along the south-western and south-eastern boundaries of Lot 5, D.P. 41103, the end of Otaha Road, the south-eastern boundaries of Lots 4 and 2, D.P. 41103, and the production of the last-mentioned boundary to the middle of the Takou River in Block I, Kerikeri Survey District; thence down the middle of the said river to the point of commencement; together with all adjacent islands, but excluding therefrom the Kaikohe Borough and the Kawakawa Town District as hereinbefore described.

BOUNDARIES OF KAWAKAWA RIDING OF COUNTY OF BAY OF ISLANDS

ALL that area in the North Auckland Land District, Bay of Islands County, bounded by a line commencing at the junction of the middle of the Kawakawa River with the middle of the Karetu River in Block IX, Russell Survey District, and proceeding south-easterly generally up the middle of the Karetu River to a point in line with the eastern boundary of Allotment 79, Ruapekapeka Parish; thence to and along that eastern boundary, crossing the intervening Karetu Road, along the north-eastern and eastern boundaries of Allotment 78, the end of a public road, and the northern and eastern boundaries of Allotment 94 to and along the northern boundaries of Sections 1, 2, and 3, Block XIV, Russell Survey District, and the northern end of the public road forming the south-eastern boundary, of the said Section 3 to the middle of the road; thence south-westerly generally along the middle of that road and the middle of the public road forming the eastern and south-eastern boundaries of Section 4, Block XIV, aforesaid, and the south-eastern boundary of Allotment 104 to a point in line with the north-western boundary of Allotment 106; thence to and along that north-western boundary and along the right bank of the Tirohanga Stream to and along the eastern and southern boundaries of Allotment 109 and the western boundary of Allotment 86, all the aforesaid allotments being of

Ruapekapeka Parish, along the production of the last-mentioned boundary to the southern side of the public road forming the southern boundary of the said Allotment 86, and along that southern roadside to and along the south-eastern boundary of that part of Mohinui 9 shown on D.P. 14011, along a right line across a public road to and along the southern boundary of Mohinui 9 and the south-eastern boundaries of Mohinui 8 and Motatau 2 No. 28 and the production of the last-mentioned boundary to the western side of State Highway No. 1; thence still south-westerly generally along that western side to and along the southern boundaries of Sections 14 and 13, Block IV, Motatau Survey District, and continuing along the generally eastern boundary of Section 10, Block IV, aforesaid, and the eastern boundary of Section 10, Block VIII, Motatau Survey District, crossing the intervening Newmarket-Opua Railway, to and westerly along the northern side of Opahi Road to and along the western boundary of Section 14, Block VIII, aforesaid, to and down the middle of the Ramarama Stream to a point in Block VII, Motatau Survey District, in line with the south-eastern boundary of Motatau 2, Section 57B; thence to and along that south-eastern boundary, along the south-western boundary of Motatau 2, Section 57B to the southern side of a public road, and due north to and along the generally northern side of that road and of Martin's Road to a point in line with the north-western boundary of Motatau 2, Section 55, and along a right line across Martin's Road to and along the generally north-western boundaries of Motatau 2, Sections 55 and 58, and the production of the last-mentioned boundary to the middle of the Otai Stream; thence northerly generally down the middle of that stream to a point in line with the south-western boundary of Motatau 2, Section 17; thence to and along the south-western and western boundaries of that block, crossing the intervening Pukatea Road, the south-western boundaries of Motatau 2, Sections 15 and 13, crossing the intervening Pokapu Road and the production of the last-mentioned boundary, to and down the middle of the Te Tahunaakura Stream and the middle of the Waiharakeke Stream to a point in line with the south-western boundary of Allotment 162, Kawakawa Parish, in Block XV, Kawakawa Survey District; thence to and along that south-western boundary, crossing the intervening Newmarket-Opua Railway, and Otiria-Station Road, and along a right line across the Otiria Stream to and along the south-western boundary of Lot 4, D.P. 25821, the south-western end of a public road, the south-western boundaries of Lots 3 and 2, D.P. 25821, and an area of 1 acre 2 roods 1.6 perches, set apart for railway purposes by Proclamation published in *Gazette*, 1959, p. 10, to the southern side of State Highway No. 1; thence along a right line to the southernmost corner of Allotment 165, Kawakawa parish, and along the south-western and north-western boundaries of the said Allotment 165, along the generally north-western side of the public road forming the north-western boundaries of Allotments 166 and 167, Kawakawa Parish, to and along the north-eastern boundary of Section 2, Block XI, Kawakawa Survey District, and continuing along the western boundary of Allotment 193A, Kawakawa Parish, and the south-western side of the public road forming the south-western boundary of Lot 2, D.P. 26645, to and along the south-western boundary of Lot 6, D.P. 26645, to and northerly along the right bank of the Werowero Stream to the northernmost corner of Allotment 136, Kawakawa Parish; thence easterly generally along the north-eastern boundary of Allotment 136 to and along the end of a public road to and along the middle of that road which forms the south-western boundary of Lots 3 and 4, D.P. 33146, and the south-western and south-eastern boundaries of Lot 1, D.P. 26574, to a point in line with the western side of the public road forming the western boundaries of Lot 4, D.P. 26574, and Allotment 256, Kawakawa Parish; thence to and along that western side to a point in line with the northern boundary of Allotment 74; thence to and along that northern boundary and the south-western side of the public road forming the north-eastern boundary of the said Allotment 74 and the production across a public road of that south-western side to and still easterly generally along the generally south-eastern side of the public road forming the north-western boundary of Allotments 135, 50, and 51, and continuing along the western and north-eastern boundaries of Allotment 51 and the north-eastern boundary of Allotment 47 to and along the north-western boundary of Allotment 45 and the south-western and north-western sides of the public road forming the north-eastern and south-eastern boundaries of Allotment 45 to the south-eastern corner of that allotment; thence along a right line to the westernmost corner of Allotment 44, along the southern boundaries of Allotments 44 and 43, crossing the intervening McIntyres Road, to and along the south-western, western, and north-western boundaries of Allotment 253 and the eastern boundary of Allotment 14 and its production to the middle of a public road; thence still easterly generally along the middle of that public road which forms the northern boundary of Allotments 11 and 10, the western and northern boundaries of Allotment 7, the generally
