"THAT, in pursuance and exercise of the powers vested in it by the Municipal Corporations Act 1954, the Local Authorities Loans Act 1956, and all other powers enabling it in that behalf, the Milton Borough Council hereby resolves that, for the purposes of repayment on maturity of the Sewerage No. 1 Redemption Loan 1969—\$14,000 and interest thereon the Council appropriates and pledges a special annually recurring rate of decimal two (.2) cents in the dollar (\$) upon the rateable value (on the basis of unimproved value) of all property in the Borough of Milton, comprising the whole of the Borough of Milton."
