Station C. and the production of that line to and along the middle of No. 3 State Highway to a point in line with the north-western boundary of Lot 3, D.P. 17859, to and along that boundary and its production to the north-eastern side of the Marton. New Plymouth Railway, along a right line to the Marton-New Plymouth Railway, along a right line to Trig. Station EE., along a right line to the angle in the southwestern boundary of Section 96, Waitotara District (9829 links from the south-eastern corner of the said Section 96), and along the production of that line to the sea coast; thence propthy yesterly and north-easterly along the sea north-westerly, northerly, and north-easterly along the sea coast to the point of commencement.

Secondly, also the territorial sea and sea bed lying within the seaward projection of the side boundaries of the area first described.
