OPOTIKI BOROUGH COUNCIL

RESOLUTION MAKING SPECIAL RATE

Reserve Grandstand Loan 1969, \$5,500

PURSUANT to the Local Authorities Loans Act 1956, the Opotiki Borough Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of \$5,500 authorised to be raised by the Opotiki Borough Council under the above-mentioned Act for the purpose of completing the erection of a grandstand on the reserve, the said Opotiki Borough Council hereby makes and levies a special rate of decimal point nought four four cent (.044c) in the dollar (\$) upon the rateable property of the Borough of Opotiki; and that the special rate shall be an annually recurring rate during the currency of the loan and be payable half-yearly on the 1st day of June and the 1st day of December in each and every year during the currency of the loan, being a period of twenty (20) years or until the loan is fully paid off."

The foregoing resolution was passed at a special meeting of the Opotiki Borough Council held on the 23rd day of February 1970.

RESOLUTION MAKING SPECIAL RATE

Rural Housing Loan (11) 1969—\$300,000

PURSUANT to the Local Authorities Loans Act 1956, the Waikato County Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of \$300,000 authorised to be raised by the Waikato County Council under the above-mentioned Act for the purpose of making advances to farmers in terms of the Rural
