NOTICE

1. This notice may be cited as the Traffic (60-miles-an hour) Notice No. 4, 1970.

2. The roads specified in the Schedule hereto are hereby declared to be 60-miles-an-hour speed limit areas for the purposes of regulation 27B of the Traffic Regulations 1956*.

SITUATED within Taupo County:

No. 1 State Highway (Awanui-Bluff) (from Poihipi Road to a point 3 miles and 21 chains measured northerly generally along the said State highway from Poihipi Road).
