Declaring Part of a Soil Conservation Reserve in Block IV, Puketapu Survey District, Hawke's Bay County, to be Crown Land

#### A PROCLAMATION

PURSUANT to section 20 of the Soil Conservation and Rivers Control Act 1941, I, the Right Hon. Sir Herbert Richard Churton Wild, the Administrator of the Government of New Zealand, hereby declare the land described in the Schedule hereto to be Crown land within the meaning of the Land Act 1948.

#### HAWKE'S BAY LAND DISTRICT

ALL that piece of land containing 146 acres 1 rood, being Section 29, Block IV, Puketapu Survey District; as the same is more particularly delineated on the plan marked P.W.D. 128500 (S.O. 2235) deposited in the office of the Minister of Works at Wellington, and thereon edged red.
