A PROCLAMATION

PURSUANT to section 226 of the Public Works Act 1928, I, the Right Hon. Sir Herbert Richard Churton Wild, the Administrator of the Government of New Zealand, hereby proclaim and declare that the land described in the Schedule hereto shall, upon the publication hereof in the *Gazette*, become road; and that the said road shall be under the control of the Matamata County Council and shall be maintained by the said Council in like manner as other public highways are controlled and maintained by the said Council.
