Price Order No. 2141 (Amendment No. 7 of Price Order No. 2117) (Eggs)

Pursuant to the Control of Prices Act 1947, I, Clifford Ernest Beard, pursuant to a delegation from the Secretary of Industries and Commerce, acting under a delegation from the Price Tribunal, hereby make the following price order:

- 1. This order may be cited as Price Order No. 2141 and shall be read together with and deemed part of Price Order No. 2117* (hereinafter referred to as the principal order).
 - 2. This order shall come into force on the 19th day of September 1970.
 - 3. The principal order is hereby amended by revoking the Schedule thereto, and substituting the following Schedule.
