National Roads Board—Notice Partially Revoking Declaration of State Highway to be Limited Access Road

PURSUANT to subsection 5 of section 4 of the Public Works Amendment Act 1963, the National Roads Board hereby revokes its resolution of 18 March 1970, pursuant to section 4 of the Public Works Amendment Act 1963, declaring that part of No. 1 State Highway (Awanui-Bluff) from a point approximately 8 chains south from its intersection with Kapiti Road to its intersection with Beach Road, Paekakariki, a total distance of approximately 6 miles 16 chains, as more particularly shown on sheets 1, 2, 3, and 4 of plans M.O.W. 16155 and the accompanying schedule, held in the office of the resident engineer, Ministry of Works, Porirua, and there available for public inspection, to be a limited access road in so far as the aforementioned declaration affects the said No. 1 State Highway for a distance of 30 ft measured in a
