## Special Conditions

- No person shall use or cause to be used for the hunting or killing of game on Lake Waikare any fixed stand, pontoon, hide, maimai, or loo, except within 200 yd of the margin of the said lake.
- No person shall use or cause to be used for the hunting or killing of game on Lake Ngaroto any fixed stand, pontoon, hide, maimai, or loo, except within 90 yd of the margin of the said lake.
- It shall be an offence for any person to wilfully leave any swan(s) shot or the mutilated bodies of any swan(s) shot in the Auckland Acclimatisation District.
- It shall be an offence to occupy any stand, pontoon, hide, maimai, or loo, for the purpose of shooting, with duck decoys set, after the end of the duck season.
