Pursuant to the Local Authorities Loans Act 1956, the Dunedin City Council hereby resolves as follows:

That, for the purpose of providing the annual charges on a loan of \$200,000 authorised to be raised by the Dunedin City Council under the above-mentioned Act, for the purpose of purchasing land and erecting accommodation for old people, the said Dunedin City Council hereby makes a special rate of 0.0185 cent in the dollar (\$) upon the rateable value of all rateable property of the City of Dunedin, comprising the whole of the City of Dunedin, and that the special rate shall be an annual-recurring rate during the currency of the loan, and be payable yearly on the 1st day of June in each and every year during the currency of the loan, being a period of thirty (30) years, or until the loan is fully paid off.

THAT, in pursuance and exercise of the powers vested in it in that behalf by the Local Authorities Loans Act 1956, the Franklin County Council hereby resolves as follows:
