

Settlement aforesaid, to and along the northern and western boundaries of part Tairua Block shown on S.O. Plan 44964, to and along the northern, western, and southern boundaries of Section 13, Block XIII, Whitianga Survey District, to and along the western and southern boundaries of Section 2, Block XIII, aforesaid, to and along the western side of Provincial State Highway No. 25, to and along the north-eastern, northern, western, and south-western boundaries of Section 9, Block XIII, Whitianga Survey District, to and again along the western side of Provincial State Highway Number 25 to the north-eastern boundary of Section 16s, Hikuai Settlement;
