

THIRD SCHEDULE

ALL that area in the South Auckland Land District, Counties of Thames and Ohinemuri, situated in Tairua, Waihou, and Ohinemuri Survey Districts, containing 35,428 acres 2 roods 13.6 perches, more or less, bounded by a line commencing at the westernmost corner of Section 19, Block I, Ohinemuri Survey District, and proceeding northerly and easterly generally along the western boundary of Section 19 aforesaid, along a right line to and along the western, northern, and eastern boundaries of another portion of Section 19, aforesaid, to the northern side of Omahu-Otamakite Road; thence westerly along the northern side of Omahu-Otamakite Road to a point in line with the western boundary of Section 17, Block XIII, Tairua Survey District; thence southerly and easterly generally along a right line to and along the western and southern boundaries of Section 17 aforesaid, the southern boundary of Section 4, Block XIII aforesaid, the south-western, south-eastern, and north-eastern boundaries of Section 5, Block XIII, aforesaid, the north-western and north-eastern boundaries of Section 1, Block II, Ohinemuri Survey District, and the southern boundary of an area of Crown land to the left bank of the Tairua River; thence south-easterly generally along the left bank of the Tairua River, to and along the north-western end of a public road, to and along the northern boundary of Section 6, Block II, Ohinemuri Survey District, to its north-eastern corner; thence easterly and southerly generally along a right line to and along the northern and eastern boundaries of Section 7, Block II aforesaid, to a point in line with the eastern boundary of Section 8, Block II, aforesaid; thence southerly and westerly generally along a right line to and along the eastern and southern boundaries of Section 8 aforesaid, to its westernmost corner; thence south-westerly generally along a right line to and along the southern boundary of Section 7, Block II aforesaid, and along a right line being the last-mentioned boundary produced to and along the south-eastern boundary of Section 6, Block II, aforesaid, and along the north-west side of a public road to a point in line with the south-west boundary of Allotment 2, of Section 3, Block II, aforesaid; thence south-easterly and northerly generally along the south-western and eastern boundaries of Allotment 2, of Section 3, Block II aforesaid, to a public road; thence easterly generally along the south side of that public road to and along the south-western boundary of Section 11, Block III, Ohinemuri Survey District, and along a right line being the last-mentioned boundary produced to the right bank of the Otahu Stream; thence north-easterly generally along the right bank of the Otahu Stream to the western end of a public road; thence south-easterly generally along the western end of the aforesaid public road to and along the western boundaries of part Section 5 and Sections 46, 48, 49, and 66, Block IV, Ohinemuri Survey District, and the south-western boundaries of Sections 7 and 8, Block VIII, Ohinemuri Survey District, Crown land, and Section 9, Block VIII aforesaid, to the southernmost corner of the last-mentioned section; thence north-easterly generally along the south-eastern boundary of Section 9, aforesaid, to the western boundary of Section 10, Block VIII aforesaid; thence southerly generally along the western boundary of Section 10 aforesaid, the north-western and south-western boundaries of Section 11, Block VIII, aforesaid, the south-western boundary of Section 14, Block VIII, aforesaid, the western boundary of part Mataora 2 Block, to and along the western side of Provincial State Highway No. 25, to and along the western boundary of Section 2, Block VIII aforesaid, to the southernmost corner of the last-mentioned section; thence westerly generally along the northern boundary of Section 64, Block XII, Ohinemuri Survey District, to and along the northern side of Corbett's Road to a point in line with the western boundary of Section 63, Block XII aforesaid; thence southerly generally along the western boundary of Section 63, Block XII aforesaid, to and along the western side of Corbett's Road, to and along the western boundaries of Sections 67 and 42, Block XII aforesaid, to the westernmost corner of Section 42 aforesaid; thence westerly generally along a right line to and along the southern boundary of Section 62, Block XII aforesaid, to and along the south-eastern boundary of part Ohinemuri 3 Block, to and along the northern boundary of Section 6, Block XI, Ohinemuri Survey District, to the westernmost corner of the last-mentioned section; thence southerly and westerly generally along the western boundaries of Section 6 aforesaid, and Section 12, Block XI aforesaid, to and along the eastern and southern boundaries of Section 11, Block XI, aforesaid, to a point in line with the south portion of the eastern boundary of Section 287, Block XV, Ohinemuri Survey District; thence southerly, westerly, and northerly generally along a right line to and along the eastern, southern, south-western, and north-western boundaries of Section 287, aforesaid, to the northernmost corner of that section; thence northerly generally along a right line to and along the eastern boundaries of Sections 15 and 14, Block XI, Ohinemuri Survey District, to and along the southern, eastern, and northern boundaries of Section 8, aforesaid, to and along the south-eastern boundary of Section 20, Block XI aforesaid, the eastern boundary of Section 13, Block XI aforesaid, to the north-eastern corner of the last-mentioned section; thence northerly along a right line to and along the eastern boundaries of Sections 18 and 9, Block XI aforesaid, and Section 16, Block VI, Ohinemuri Survey District, to the northernmost corner of the last-mentioned section; thence south-westerly along the north-western boundary of Section 16 aforesaid, and along the production of that boundary to the western side of Golden Cross Road; thence southerly generally along the western side of Golden Cross Road, aforesaid, to and along the right bank of the Waitekauri River, to and along the northern and western boundaries of Section 15, Block X, Ohinemuri Survey District, the western boundary of Section 11, Block X, aforesaid, and the southern boundary of Section 19, Block X, aforesaid, to and along the right bank of the Grace Darling Stream, to and along the western side of a public road, to and along the eastern and southern boundaries of Section 17, Block X, Ohinemuri Survey District, to and along the south-eastern boundary of Section 44, Block X, aforesaid, to and along the south-eastern and southern boundaries of another portion of Section 17, Block X, aforesaid, to a point in line with the western boundary of Section 43, Block XIV, Ohinemuri Survey District; thence southerly generally to and along that boundary and the northern and south-eastern boundaries of Section 104, Block XIV, aforesaid, and southerly, westerly, and north-easterly along the eastern, southern, and north-western boundaries of Section 76, Block XIII, Ohinemuri Survey District, and northerly generally along the western and north-western boundaries of Section 104, Block XIV, aforesaid, to a point in line with the eastern boundary of Section 19, Block XIV, aforesaid; thence northerly generally along a right line to and along the eastern and northern boundaries of Section 19, aforesaid, to and along the eastern boundaries of Sections 3 and 14, Block X, aforesaid, the eastern end of a public road, the eastern and northern boundaries of Section 13, Block X, aforesaid, to and along the eastern and northern boundaries of Section 12, Block X, aforesaid, to and along the eastern side of a public road, to and along the eastern boundary of Section 4, Block VI, Ohinemuri Survey District, the south-eastern boundary of Section 12, Block VI aforesaid, and along a right line being the last-mentioned boundary produced to the right bank of the Maratoto Stream; thence north-westerly generally along the right bank of the Maratoto Stream, to and along the south-eastern and north-eastern boundaries of Section 7, Block VI, Ohinemuri Survey District, along a right line to and along the northern boundaries of Lots 2 and 1, D.P. 27269, the eastern boundary of Section 18, Block I, Ohinemuri Survey District, to the south-eastern boundary of Section 9, Block I, aforesaid; thence north-easterly, north-westerly, and south-westerly generally along the south-eastern, north-eastern, and north-western, and south-western boundaries of Section 9, Block I aforesaid, to and along the north-western boundary of Section 3, Block V, Ohinemuri Survey District, to the south-western corner of the last-mentioned section; thence north-westerly generally along the north-western side of a public road and the north-western boundaries of Hikutaia 1B1C, 1D, and 1G11 Blocks, to and along the south-eastern, north-eastern, north-western, and western boundaries of Section 1, Block I, Ohinemuri Survey District, to and along the north-eastern boundaries of Hikutaia 1H and 1G9 Blocks, the northern end of a public road, and the north-eastern boundary of Lot 3, D.P. 29925, to the south-eastern corner of Lot 1, D.P. S. 1978, thence northerly generally along the eastern and northern boundaries of Lot 1 aforesaid, to and along the eastern end of a public road, the south-eastern and north-eastern boundaries of Section 7, Block I, Ohinemuri Survey District, to and along the south-eastern and north-eastern boundaries of Section 3, Block I aforesaid, to and along the eastern boundaries of Sections 2 and 11, Block I aforesaid, to the southern boundary of Section 6, Block I aforesaid; thence easterly, northerly, and westerly generally along the southern boundary of Section 6 aforesaid, along a right line to and along the southern, eastern, and northern boundaries of Section 5, Block I, aforesaid, and the ends of public roads, and the northern boundary of another part of Section 5 aforesaid, to and along the northern boundary of Section 17, Block I, aforesaid, to the eastern boundary of Omahu West 2b3A2 Block; thence northerly and westerly generally along the eastern boundary of Omahu West 2b3A2 Block aforesaid, to and along the southern boundary of Section 19, Block I, Ohinemuri Survey District, to the point of commencement, excepting thereout all public roads (S.O. Plan 45029).

Also all that area in the South Auckland Land District, County of Thames, situated in Blocks IX and XIII, Tairua Survey District, containing 3,126 acres and 28 perches, more or less, being Sections 2, 3, 9, and 20, Block XIII, Tairua Survey District, Pakirarahi 2b2 Block, and Lot 1, D.P. S. 3479, being parts Pakirarahi 2A4A and 2A4B1B Blocks (S.O. Plan 45029).
