HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL PURSUANT to the Local Government Commission Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. This order shall come into force on 1 July 1971.
- 2. The areas described in the Schedule hereto are hereby excluded from the County of Cook and included in the City of Gisborne.
- 3. The alteration of the boundaries of the said county and the said city, hereinbefore made, shall be deemed to have been effected under the Municipal Corporations Act 1954.
- 4. Notwithstanding anything in the Order in Council dated 16 March 1964, uniting the Counties of Cook and Uawa*, the Cook County Council at any time after the 1st day of March 1974 may, in its discretion, alter the ridings of the county and the representation of the different ridings in accordance with the provisions of the Counties Act 1956.
- 5. If the Council exercises the powers conferred by Clause 4 of this order, the provisions of clauses 2, 3, and 4 of the said Order in Council shall be deemed to have been revoked on the date on which the alteration takes effect.
