

Brighams Creek in Block IX, Waitemata Survey District; thence southerly, north-easterly, easterly, and southerly generally along the boundary of the Waitemata County as described in *New Zealand Gazette*, 1969, page 2079, and continuing along the left bank of Henderson Creek to the intersection with the northern boundary of the Henderson Borough as described in *New Zealand Gazette*, 1957, page 1294, thence westerly and south-westerly along that borough boundary, to the point of commencement.

SCHEDULE 6  
TITIRANGI RIDING

ALL that area in the North Auckland Land District, Waitemata County, bounded by a line commencing in Block VII, Waitakere Survey District, at the intersection of the sea coast of the Tasman Sea and the middle of the Pararaha Stream, and proceeding north-easterly generally along the south-eastern boundary of Waitakere Riding, hereinafter described, to the westernmost corner of Lot 1, D.P. 43701, in Block II, Titirangi Survey District; thence easterly, south-westerly, and northerly generally along the boundary of the Waitemata County as described in *New Zealand Gazette*, 1969, page 2079, to the point of commencement.

SCHEDULE 7  
TE ATATU RIDING

ALL that area in the North Auckland Land District, Waitemata County, bounded by a line commencing in Block XIV, Waitemata Survey District, at the intersection of the northern boundary of the Henderson Borough, as described in *New Zealand Gazette*, 1957, page 1294, with the right bank of Henderson Creek, and proceeding northerly along that right bank and continuing northerly, easterly, southerly, and westerly generally along the boundary of the Waitemata County as described in *New Zealand Gazette*, 1969, page 2079, to a point in Block II, Titirangi Survey District, in the middle of a branch of the Oratia Stream in line with the western boundary of Lot 27, D.P. 17808; thence north-westerly generally along the boundary of Waitakere Riding, hereinafter described, to the left bank of the Oratia Stream; thence north-easterly, northerly, and north-westerly along the boundary of the Henderson Borough aforesaid, to the point of commencement.

SCHEDULE 8  
WAITAKERE RIDING

ALL that area in the North Auckland Land District, Waitemata County, bounded by a line commencing in Block I, Waitakere Survey District, at the intersection of the sea coast of the Tasman Sea and the middle of the Waitakere River, and proceeding north-easterly generally along the south-eastern boundary of Kumeu Riding, hereinbefore described, to a point in the middle of the Swanson-Kumeu Road in line with the northern boundary of Lot 2, D.P. 6593, in Block XIII, Waitemata Survey District; thence southerly along the middle of the Swanson-Kumeu Road, westerly of the Waitakere Railway Station, and south-easterly along the middle of the Henderson-Kumeu via Swanson Road, crossing the intervening Kumeu Stream and the Newmarket-Opua Railway, to a point in line with the middle of Christian Road; thence south-easterly along a right line, to and along the middle of that road to a point in line with the southern boundary of Allotment 121, Waipareira Parish; thence easterly along a right line, to and along that southern boundary, to and southerly and easterly along the western and southern boundaries of Lot 2, D.P. 14646, and the last boundary produced, to and southerly along the middle of O'Neills Road to a point in line with the southern boundary of Allotment 192, Waipareira Parish; thence easterly along a right line, to and along the southern boundary of that Allotment 192, to and south-easterly and easterly along the south-western and southern boundaries of Allotment 200, Waipareira Parish, and the last boundary produced, to and south-easterly along the middle of Candia Road to a point in line with the northern boundary of Lot 54, D.P. 22288; thence along a right line, to and along the northern boundaries of Lots 54 and 40, D.P. 22288, and the last boundary produced, to and southerly along the middle of Simpsons Road to a point in line with the northern boundary of Lot 7, D.P. 7398, in Block XIV, Waitemata Survey District; thence easterly along a right line, to and along that northern boundary, to and northerly and easterly along the western and northern boundaries of Lot 2, D.P. 43647, to and south-easterly along the south-western boundary of Lot 24, D.P. 1467, to and north-easterly along the south-eastern boundaries of Lot 24 aforesaid, Lot 5, D.P. 9118, and Lot 22, D.P. 1467, to and south-easterly along the southern side of the Newmarket-Opua Railway to a point in line with the north-western boundary of an area of 15.25 perches, shown

coloured yellow, on S.O. Plan 29873, and taken for railway by *New Zealand Gazette*, 1939, page 2; thence north-easterly along a right line to the westernmost corner of that area; thence easterly, southerly, and easterly generally along the boundary of the Henderson Borough as described in *New Zealand Gazette*, 1957, page 1294, to the junction in Block II, Titirangi Survey District, of the northern boundary of part Lot 11, Deeds Plan Whau 13, comprised in certificate of title, Volume 588, folio 309, being part Allotment 2, Waikomiti Parish, with the left bank of the Oratia Stream; thence easterly along the production of the northern boundary of the aforesaid part Lot 11, to and southerly up the middle of the Oratia Stream, to and southerly along the western side of the Newmarket-Opua Railway, to and south-easterly up the middle of a branch of the Oratia Stream to a point in line with the western boundary of Lot 27, D.P. 17808; thence southerly along the boundary of the Waitemata County as described in *New Zealand Gazette*, 1969, page 2079, to the westernmost corner of Lot 1, D.P. 43701; thence south-easterly along the south-western boundary of that Lot 1, to and easterly along the southern boundary of Lot 2, D.P. 43701, to and southerly along the western boundaries of Lots 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, and 15, D.P. 43701, to the south-western corner of Lot 15; thence southerly along a right line across part Lot 1, D.P. 28402, to the north-western corner of Lot 16, D.P. 43701; thence southerly along the western boundaries of Lots 16, 17, 18, 19, 20, 21, 22, 23, and 24, D.P. 43701, to and westerly along the southern boundary of Lot 1, D.P. 28402, to and southerly along the eastern boundary of Lot 1, D.P. 7428, and its production to the middle of Waitakere Scenic Drive in Block VI, Titirangi Survey District; thence westerly along the middle of Waitakere Scenic Drive, to a point in line with the eastern boundary of Lot 4, D.P. 42411; thence southerly along a right line, to and along that boundary and continuing along the eastern boundary of Allotment 17, Waikomiti Parish, to the northernmost corner of Lot 1, D.P. 35700; thence westerly along the northern boundary of that Lot 1, along a right line across Part Allotment 17, to and along the southern boundary of Lot 5, D.P. 62772, to and northerly along the western boundaries of Lots 5 and 4, D.P. 62772, Lot 2, D.P. 63764, and Lot 1, D.P. 62772, and the last boundary produced to the middle of Waitakere Scenic Drive; thence westerly and south-westerly along the middle of Waitakere Scenic Drive, to and south-easterly along the middle of Shaw Road to its southern end; thence westerly along the southern end of Shaw Road, and the southern boundaries of Lots 27, 26, 25, 24, and 23, D.P. 37552, to and south-westerly along the south-eastern boundaries of Lots 22, 21, 20, 19, and 18, D.P. 37552, and Lots 3, 2, and 1, D.P. 49446, to and southerly and westerly along the eastern and southern boundaries of Lot 13, D.P. 37552, to and southerly along the western boundaries of Allotment 30, crossing the intervening public road, to the southernmost corner of Lot 1, D.P. 50278; thence westerly and southerly along the northern and western boundaries of Allotment 31, to and westerly along the northern boundaries of Allotments 56 and 55, crossing an intervening area of 12 acres 2 roods 15 perches, being stopped road, shown on S.O. Plan 40327, to and northerly and westerly along the eastern, and northern boundaries of Allotment 37, to and along the eastern boundary of Allotment 38; thence northerly, westerly, and southerly along the eastern, northern, and western boundaries of Allotment 38, as shown on S.O. Plan 27CL, crossing and recrossing the intervening public roads, and the last boundary produced to the middle of the Nihotupu Stream in Block V, Titirangi Survey District, all the aforesaid allotments being of Waikomiti Parish; thence southerly and westerly generally up the middle of the aforesaid stream to a point in line with the western boundary of Lot 2, D.P. 9782; thence southerly along a right line, to and along that boundary and continuing along the eastern boundary of Allotment 30, Karangahape Parish, to the south-eastern corner of that Allotment; thence south-westerly along a right line to the northernmost corner of Allotment 8A and westerly and southerly along the northern and western boundaries of that allotment, to a point in line with the north-eastern boundary of Allotment 109, in Block IX, Titirangi Survey District; thence north-westerly along a right line, crossing Huia Stream, to and along the aforesaid boundary and south-westerly and south-easterly along the north-western and south-western boundaries of Allotment 109, to and south-westerly along the north-western boundary of Allotment 17, to and north-westerly, south-westerly, and south-easterly along the north-eastern, north-western, and south-western boundaries of Allotment W. 15, to and south-westerly along the north-western boundary of Allotment 10, and the last boundary produced to the middle of a public road; thence north-westerly along the middle of the aforesaid public road forming the north-eastern boundaries of Allotments 21, E. 20, and W. 20, to and north-easterly along the south-eastern boundary of Allotment N.E. 66 and its production to and north-westerly along the middle of a public road forming the generally north-
