###### *Electricity Renewal Loan No. 2, 1971*

Resolution Passed by the Dunedin City Council on Monday, 28 June 1971

PURSUANT to the Local Authorities Loans Act 1956, the Dunedin City Council hereby resolves as follows:

That, for the purpose of providing the annual charges on a loan of \$197,200, authorised to be raised by the Dunedin City Council under the above-mentioned Act, for the purpose of repaying on maturity those portions of the Electricity Development Loan 1959 of \$1,000,000 and the Electricity Development Loan 1960 of \$600,000 which mature on 15 August 1971, the said Dunedin City Council hereby makes a special rate of 0.0459c in the dollar (\$) upon the rateable value of all rateable property of the City of Dunedin, comprising the whole of the City of Dunedin, and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of June in each and every year during the currency of the loan, being a period of six (6) and ten (10) years, or until the loan is fully paid off.
