"That, for the purpose of providing the annual charges on a loan of two hundred and eighty-three thousand eight hundred dollars, authorised to be raised by the Wellington City Council under the above-mentioned Act, for the purpose of repaying on maturity those portions of City Works Loan No. 2, 1950 of \$870,400, Te Aro Flat Development Loan No. 3, 1958 of \$200,000, Street Works Loan 1955 of \$1,100,000, Electricity Loan No. 2 1957 of \$1,050,000, Abattoir Loan 1959 of \$1,000,000, Abattoir Loan 1965 of \$360,000, Johnsonville Sewerage Loan 1961 of \$162,000, and Renewal Loan No. 4, 1965 of \$459,800, which mature on 1 November 1971, the said Wellington City Council hereby makes a special rate of decimal nought one four of a cent (.014c) in the dollar upon the rateable value (on the basis of the unimproved value) of all rateable property within the whole of the City of Wellington, and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable yearly on the 1st day of April in each and every year during the currency of the loan, being a period of fifteen (15) years or until the loan is fully paid off."
