Duck Creek Works Redemption Loan No. 3, 1971-\$4,400 In pursuance and exercise of the powers vested in it by the Local Authorities Loans Act 1956, and the Soil Conservation

and Rivers Control Act 1941, and all other powers in that behalf it enabling, the Southland Catchment Board hereby resolves as follows:
