*Setting Aside Maori Freehold Land as a Maori Reservation*

WHEREAS by Order in Council, dated 24 September 1958, and published in *Gazette*, 2 October 1958, No. 59, page 1315, the Maori freehold land described in the First Schedule hereto was set apart as a Maori reservation; and whereas it is desired

to amend the area set apart; and whereas the Maori Land Court has given its support to such a variation; now, therefore, pursuant to section 439 of the Maori Affairs Act 1953, notice is hereby given as follows:

1. The reservation constituted by Order in Council, dated 24 September 1958 and published in *Gazette*, 2 October 1958, No. 59, page 1315, relating to the land described in the First Schedule hereto is hereby cancelled.

2. The whole of the land described in the Second Schedule hereto is hereby set apart as a Maori reservation for the purpose of a meeting place, recreation ground, and sports ground for the common use and benefit of the Ngati Pukenga tribe and to be called "Te Whetu Marae".
