Bylaw Fixing the Maximum Speed of Vehicles on the Auckland-Hamilton Motorway (Green Lane-Symonds Street)

BYLAW

PURSUANT to section 13 of the National Roads Act 1953 and section 72 of the Transport Act 1962, the National Roads Board hereby makes the following bylaw:

- 1. This bylaw may be cited as the National Roads Board Bylaw 1972, No. 3.
- 2. This bylaw shall come into force on the day after the date of its publication in the Gazette.
- 3. In this bylaw "vehicle" has the meaning assigned to it in the Transport Act 1962.
- 4. No person shall drive or take or permit to be driven or taken any vehicle upon the Auckland-Hamilton Motorway (between Symonds Street and the motorway interchange at Green Lane) at a speed exceeding 50 miles per hour.
- 5. Every person who commits an offence against this bylaw is liable on summary conviction to a fine not exceeding \$100.

This bylaw was made by resolution duly passed at a meeting of the National Roads Board held in Wellington on the 13th day of December 1972.
