SECOND SCHEDULE

Description of Sewage Drainage Easement

THE full and free right, liberty, licence, and authority for Her Majesty the Queen to lay, construct, place, reconstruct, inspect, cleanse, repair, renew, and maintain a pipe drain under, along, and across the land described in the Third Schedule hereto and to use the said pipe drain for the unimpeded conveyance of sewage from the Crown's sewage treatment works situated on the land described in the First Schedule hereto, and shall include the full and free right, liberty, licence, privilege, and authority to Her Majesty's servants, agents, and workmen, from time to time and at all times hereafter, to enter upon the land described in the Third Schedule to do such work as may be necessary or desirable for any purpose connected with the said sewage drainage easement and for the inspection, maintenance, installation, repair, or replacement of the said pipe drain and any associated equipment or fittings, so that the same may be kept in good and efficient working order; such sewage drainage easement to be held appurtenant to the land described in the First Schedule hereto.
