S. 1769, Lot D1, D.P. 3600, Lots C and A, D.P. 2894 and that last boundary produced to the middle of the Waikato River; thence south-easterly up the middle of the Waikato River to a point in line with the western boundary of part Pukekura No. 1, shown on D.P. 27186; thence generally southerly to and along the said western boundary, along a right line crossing a public road to and along the generally western boundaries of part Pukekura No. 1, part Section 1, Block XIV, Cambridge Survey District, parts Pukekura Nos. 1, 2, and 3, part Pukekura No. 4, shown on D.P. 9392, Pukekura 5, Section 1, and part No. 6 along the south-western boundary of Pukekura No. 7, the north-western boundary of Pukekura 8A, and the western boundaries of Pukekura Nos. 9, 10, 11, 12, part 13, part 14, to the southernmost corner of the said part 14; thence south-easterly along a right line between that corner and Trig. Station 1427 (Maungatautari), in Block VII, Maungatautari Survey District, to the eastern boundary of Maungatautari 3A5A8; thence south-westerly along that boundary, the eastern boundaries of Lot 1, D.P. S. 10003, the eastern and southern boundaries of part Maungatautari 3A5A1, a right line across Maru Road to and along the eastern and southern boundaries of part Lot 4, D.P. 12622, to and along the eastern boundaries of Sections 3, 5 and 11, Block V, Maungatautari Survey District, along a right line across a public road to and along the eastern boundaries of Sections 5 and 6, Block IX, Maungatautari Survey District, and that last boundary produced to the middle of the Mangahoi Stream; thence north-westerly along the middle of that stream to a point in line with the middle of the road which forms the south-eastern boundaries of Allotments 39, 52, 53, and 56, Puniu Parish; thence south-westerly to and along the middle of that road, the middle of Kihikihi Arapuni Road and Brotherhood Road to and along and up the middle of the Puniu River to its confluence with the Moerika Stream in Block XI, Puniu Survey District; thence generally westerly along a right line to the north-eastern corner of Lot 2, D.P. 21236, along the northern and western boundaries of that lot to a point in line with the northern boundary of Lot 1, D.P. S. 2050, along a right line across National State Highway No. 3 to and along the said northern boundary and the northern boundary of Lot 2, D.P. S. 2050, to the north-western corner of that lot, along a right line to the northernmost corner of Tokanui C11, being part of the land included in part Lot 1, D.P. 4924, along the north-western boundary of the aforesaid part Lot 1, the eastern and northern boundaries of Lot 1, D.P. 12868, the northern and western boundaries of Section 7, Block X, Puniu Survey District, the northern boundaries of part Lot 2, D.P. 12868, and part Ouruwhero 3Y2C and that last-named boundary produced to the western side of the North Island main trunk railway; thence along the western side to and along the northern boundary of the Te Kawa Railway Station, shown on S.O. 3908, Sheet 7, the northern end of Hinewai Street and the northern boundary of Lot 1, D.P. 25224, along the eastern and northern boundaries of part Ouruwhero 3.0 1, and the northern boundaries of part Ouruwhero 3.0 2C2 and 3.0 3, Lot 1, D.P. 6657, Lot 2, D.P. 15110, and the original northern boundaries of Ouruwhero 3E5B and 3E2, passing through Sections 11 and 10, Block IX, Puniu Survey District to and along the northern boundaries of part Lot 10, D.P. 23042, and Lot 1, D.P. 23897, a right line across the Te Awamutu - Bartons Corner Road, to and along the northern boundary of part Ouruwhero 3E1A, and that boundary produced to the middle of the Waipa River in Block XII, Pirongia Survey District; thence northerly down the middle of that river to and southerly up the middle of the Mangauika Stream in Block IV, Pirongia Survey District, to and generally westerly along the northern boundaries of Sections 2, 11, and 9, the western boundaries of the said Section 9 and Section 10, all the said sections being in Block IV, Pirongia Survey District, to Trig. Station 1921 (Pukehoua); thence along the northern boundary of Kaipiha No. 5, the western boundary of the said No. 5, and Kaipiha, Nos. 4, 3, 2, and 1C, the northern boundary of part Section 3, Block VII, Pirongia Survey District, the eastern boundary of Section 18, Block VII aforesaid, the northern boundaries of that Section and Mangauika A1, to and north-easterly along the south-eastern boundary of part Pirongia West 3A to Trig. Station 1922 (Mahaukura); thence generally westerly along the south-western boundary of Allotment 358, Pirongia Parish, the end of a public road, the south-western boundaries of Allotments 352 and 428, Pirongia Parish aforesaid, and the end of another public road to Trig. Station, Tahuauui; thence along the south-eastern, southern, and western boundaries of part Moerangi No. 4 Block (State forest, *New Zealand Gazette*, 1948, page 1341); and along the southern boundary of Section 6, Block I, Pirongia Survey District, to its south-western corner, along a right line across Section 9, Block I, aforesaid, to an angle opposite in its western boundary and along that western boundary to and along the southern and western boundaries of Section 7, Block I, of the said Survey District, along the southern boundary of Section 4, Block IV, Kawhia North Survey District, and a right line from its south-western corner across Kopunui Road, to the nearest road angle on the eastern boundary of Section 18 of the said Block IV; thence along the western side of that road, to and along the generally southern boundaries of Section 8 and Lot 2 of Section 7, Block XV, Karioi Survey District, to and along the eastern boundary of Section 1, Block III, Kawhia North Survey District, along the generally southern boundary of Section 2, Block III, aforesaid, along the southern and south-western boundaries of part Moerangi No. 3D2 Block, along a right line across a public road to and along the south-western boundary of Part Moerangi No. 3D2 Block aforesaid, and along the southern boundary of Moerangi No. 3D1 Block, to the shores of the Aotea Harbour; thence along the northern shore of that harbour to the point of commencement.

ALL that piece bounded by a line commencing at a point in Block X, Maramarua Survey District, in the middle of the Waikato River, in line with the southern boundary of part Allotment 399, Parish of Whangamarino, on the southern boundary of the Electoral District of Franklin, hereinbefore described and proceeding generally easterly and northerly along that last boundary to
