

boundary of Lot 1 of Section 24, and the north-western boundary of Section 23, both the aforesaid sections being of Block II, Motu Survey District, to and along the north-western boundary of Whakapaupakihi No. 2 to Trig. Station No. 149 (Moutohora); thence southerly along a right line to Trig. Station No. 149A; thence south-westerly along a right line to Trig. Station Pokaikiri, being the southernmost corner of Block II, Motu West Survey District; thence south-westerly along the north-western boundaries of Section 2, Block V, and Sections 2, 1, and 4, Block IX, Motu Survey District, to and along the north-western boundaries of Sections 3, 2, 1, and 6, Block XII, Moanui Survey District, the north-western boundary of Section 3, Block XV, Moanui Survey District, and the production of the last-mentioned boundary to a point on the right line between Trig. Station Kaharoa, situated in Block II, Waioeke South Survey District, and Trig. Station Te Wana, being the easternmost corner of Block II, Koranga West Survey District; thence southerly along that right line to Trig. Station Te Wana aforesaid; thence generally south-westerly along the watershed between the Waimana and Waioeke Rivers to the north, and the Wairoa River to the south, to Trig. Station Maungapohatu No. 2 situated in Block XII, Ruatahuna Survey District; thence generally south-westerly, passing through Trig. Station 2126, Maungapohatu, along the south-eastern watershed of the Rangitaiki and Whakatane Rivers to its intersection, in Block I, Mangahopai West Survey District, with a right line between Trig. Station Te Taumutu, situated in Block XVI, Heruiwi Survey District, and Trig. Station Pukeroa, situated in Block XV, Heruiwi Survey District; thence generally northerly along a right line to Trig. Station B (Pukeroa) aforesaid, a right line to Trig. Station F (Tiritiri) situated in Block III, Heruiwi Survey District, a right line to Trig. Station No. 76 (Taupiri) situated in Block XII, Wheao Survey District; and along another right line bearing 323° true to its intersection with the middle of the No. 38 State Highway; thence generally northerly along the middle of that State Highway and Kaiwhatiwhati Forestry Road to its intersection with a right line between Trig. Station 18, Maungawhakamana, in Block III, Ruawahia Survey District, and Trig. Station 38, Ahiwhakamura, in Block X, Kaingaroa Survey District; along that right line to Trig. Station 18, Maungawhakamana aforesaid, a right line to the south-western corner of part Section 63, Block XV, Rotoma Survey District, a right line towards Trig. Station J, in Block IV, Waihi South Survey District, to the northern boundary of Section 12, Block VII, Rotoma Survey District; thence generally north-westerly along that boundary and the northern boundaries of Section 8, in Block VII, Rotoma Survey District, Sections 15 and 18 in Block VI, Rotoma Survey District, the western boundary of Section 9, Block VI, Rotoma Survey District, and the production of that boundary to the middle of Pongakawa Valley Road, along the middle of that road to and along the southern boundary of Section 3, Block 1, Rotoma Survey District, and the eastern boundary of part Lot 1, D.P. 13806, the eastern and south-western boundaries of Section 5 Block IV, Rotoiti Survey District, the south-western boundary of Kaikokopu Block 2B2, the southern boundaries of Section 3, Part Section 4, a lot on D.P. S. 9496, and part Section 1 of Block IV, Rotoiti Survey District, to its south-westernmost corner, and crossing all intervening public roads; thence generally westerly along the southern boundary of Section 2, Block XV, Maketu Survey District to the left bank of the Pokopoko Stream, along that left bank to and along the southern boundary of Part 3A, Taheke Block, and its production to the western side of No. 33 State Highway; along the western side of that State highway and the north-eastern boundary of Okere 1E and its production to the Kaituna River; thence down the middle of that river to a point in line with the northern boundary of Ngatipahiko 31B, thence westerly to and along that boundary and the southern boundary of Block XIV, Maketu Survey District, and the production of that boundary to the middle of the Mangorewa River along the middle of that river to the eastern boundary of Taumata 3A2B Block being the eastern boundary of the Electoral District of Coromandel hereinbefore described; thence generally north-easterly along that boundary to the point of commencement.

#### KING COUNTRY

ALL that piece bounded by a line commencing at Pourewa Point at the entrance of Aotea Harbour and proceeding generally easterly along the shore of Aotea Harbour and the southern boundaries of the Electoral Districts of Raglan and Piako hereinbefore described to the middle of the Waikato River; thence generally south-easterly up the middle of that river, the Mangakino Stream, the Mangakawiriwiri Stream, the middle of No. 32 State Highway to the northern boundary of Waihaha Block; thence generally south-easterly along that boundary to the shore of Lake Taupo; thence generally southerly along the shore of Lake Taupo to the south-eastern boundary of Tauranga-Taupo Pt 1B2, and along the south-western boundaries of Tauranga-Taupo 1B2, 1B1, and 1A to its south-easternmost corner; thence along a right line across the Tauranga-Taupo River to and south-easterly along the south-eastern boundary of Tauranga-Taupo 2A, the south-western and southern boundaries of Tauranga-Taupo 3A, the western and southern boundaries of Kaimanawa 1B, the western and southern boundaries of Kaimanawa Pt 1A and the production of that line to the middle of the Mangemingi Stream; thence down the middle of that stream and the Ngaruroro River to a point in line with Trig. Station 26, Tauwhekewhango in Block XII, Mangamaire Survey District, and Trig. Station 65A in Block XXI, Kaweka Survey District; thence westerly along that right line to Trig. Station 26 aforesaid; thence south-westerly along a right line to Trig. Station 27, Motumatai, in Block XV, Mangamaire Survey District; thence westerly along a right line to Trig. Station 28, Manukaiapu, in Block XVI, Kaimanawa Survey District and along another right line to Trig. Station Ruapehu in Block XI, Ruapehu Survey District; thence northerly along a right line to Trig. Station H, Paretaitonga, in Block XI, aforesaid; thence westerly along a right line to Te Kahatu Trig. Station, a right line to the source of the Makatote Stream and down the middle
