

the production of the last-mentioned boundary to the middle of the Rotohanganui Stream; thence generally north-easterly along the middle of that stream to a point in line with the southern boundary of Kaikou A3A Block; thence generally north-easterly along a right line, crossing Omauri Road, to and along the southern and eastern boundaries of that block, along a right line across a public road and the Kaikou River, to and along the south-eastern boundaries of Kaikou A2 and A1 Blocks, the south-western, south-eastern, and north-eastern boundaries of Maromaku Block, the southern boundaries of Lots 63 and 64, D.P. 9582, to and along the south-western and eastern boundaries of Section 4, Block XII, Motatau Survey District, the southern boundary of Section 18, Block IX, Hukerenui Survey District, and the production of the last-mentioned boundary to the eastern side of Marlow Road; thence generally northerly along that eastern side to and along the southern boundary of Section 22, to and southerly along the western boundary of Section 29, the southern boundaries of Sections 29 and 30, and the south-eastern, eastern, and north-eastern boundaries of Section 31, all the aforesaid sections being of the said Block IX, to the eastern side of a public road which forms the eastern boundary of Section 28, Block IX, aforesaid; thence generally north-easterly along that side to and along the southern side of Paiaka Road to a point due south of the westernmost corner of Section 52, Block X, Hukerenui Survey District; thence generally north-easterly along a right line across Paiaka Road, to and along the southern side of that road and Wallace Road to a point in line with the eastern boundary of Section 35, Block IX, aforesaid; thence generally north-easterly to and along that eastern boundary, the southern and eastern boundaries of Section 15, Block X aforesaid, the eastern boundaries of Sections 14, 13, 12, part 11, 3, 2, and 21, all of the said Block X, crossing an intervening public road, to and along the southern boundaries of Sections 55 and 64, along a right line across a public road to and along the southern boundaries of Sections 72, 31, 3, and 4, and the western, southern, and eastern boundaries of Section 8, all the aforesaid sections being of Block VI, Hukerenui Survey District, and the production of the last-mentioned boundary to the northern side of the Awanui-Bluff State Highway No. 1; thence south-easterly along the northern side of that highway, to and along the eastern side of Tapuhi Road, crossing the railway at Hukerenui Railway Station, to the middle of the Waipukakahau Stream; thence generally south-easterly along the middle of that stream to the westernmost corner of Section 18, Block X, Hukerenui Survey District; thence south-easterly along the Newmarket-Opua railway to its intersection with the No. 1 State Highway at the southern boundary of Section 2, Block XI, Hukerenui Survey District; thence due south to the middle of that highway and generally south-easterly along the middle of that highway to a point in line with the south-eastern boundary of Allotment S.E. 38, Hikurangi Parish; thence generally north-easterly to and along the southern and eastern boundaries of Allotment S.E. 38, aforesaid, the south-eastern boundary of Section 10, Block XVI, Hukerenui Survey District, and the production of the last-mentioned boundary to the eastern side of a public road forming the generally eastern boundary of the aforesaid Section 10; thence generally north-easterly along the eastern side of the said road to and along the northern boundary of Section 3, Block XVI, aforesaid, crossing the intervening Otonga-Marua Road, and that boundary produced to and generally southerly up the middle of the Te Waiongatahuna Stream to a point in line with the southern boundary of Section 13, Block VII, Opuawhanga Survey District; thence easterly along a right line to and along that southern boundary and the southern boundaries of Sections 35 and 46, Block VII, aforesaid, to and along the southern and eastern boundaries of Section 47, and along a right line crossing Section 42 to the south-western corner of Section 44; thence generally easterly along the generally southern boundary of Section 44, all the aforesaid sections being of the said Block VII, and the last-mentioned boundary produced to and along the middle of Jubilee Road and along the middle of a public road forming the southern boundaries of Section 12, Block VII, Sections 37, 35, 28, and 26, Block VIII, and parts Sections 8 and 7, Block V, all the aforesaid sections being of Opuawhanga Survey District, to and down the middle of a stream which crosses the aforesaid road to and down the middle of the Whananaki Inlet, to the mean high-water mark of the sea; thence north-westerly, westerly, and generally south-easterly along that mean high-water mark of the sea, to the point of commencement; and including the Cavalli Islands, Motuopao, Moturoa, Murimotu, and Stephenson's Islands, the Three Kings Islands, the Poor Knights Islands, and other adjacent islands.

WHANGAREI

ALL that piece bounded by a line commencing at a point being the intersection of the mean high-water mark of the sea and the middle of the Whananaki Inlet in Block VI Opuawhanga Survey District and proceeding generally southerly along that mean high-water mark of the sea to and generally north-westerly along the mean high-water mark of Whangarei Harbour to a point due west of the northernmost corner of Lot 1, D.P. 58877; thence northerly along a right line to a point on the mean high-water mark of the said harbour due west of a point on the north-eastern boundary of Lot 2, D.P. 46909, being the northernmost corner of Lot 1, D.P. 42421; thence north-westerly along a right line between that last-mentioned point on the mean high-water mark of that harbour and a point in line with the western end of the south-eastern boundary of Section 24, Block IX, Whangarei Survey District, distant 1,100 links, in a south-westerly direction from the southernmost corner of the said Section 24 to a point due east of another point 1,000 links due south of the south-eastern corner of Section 5, Block XIII, Whangarei Survey District; thence due west to a point due south of another point, on the north-western side of the Newmarket-Opua railway, distant 750 links measured in a south-westerly direction along the north-western side from the north-eastern boundary of Te Rewarewa B2; thence due north to and along the north-western side of that railway to and westerly along the generally northern boundaries
