

section 1081, Block II, Halswell Survey District; thence westerly along the southern boundary of that section and part Section 1592 to the eastern boundary of Part Section 1350, all in Block II, Halswell Survey District; thence south-westerly along the eastern boundary of the said part Section 1350 along a right line across Taitapu Road to the north-easternmost corner of Section 950, Block II, Halswell Survey District; thence generally north-westerly to and up the middle of the Halswell River and Knights Stream to a point in line with the north-western boundary of R.S. 952; thence north-easterly to and along that north-western boundary and its production to the middle of Halswell Junction Road; thence north-westerly along the middle of Halswell Junction Road and Main South Road to a point in line with the middle line of Pound Road; thence north-easterly to and along the middle of that road, McArthurs Road, and its production to the boundary of the Electoral District of Rangiora, hereinbefore described; thence generally south-easterly along that boundary and the south-eastern boundary of the Electoral Districts of Papanui and Riccarton; hereinbefore described, to the point of commencement.

#### SYDENHAM

ALL that piece bounded by a line commencing at a point in the middle of the Heathcote River in line with the middle line of Waltham Road, being a point on the generally southern boundary of the Electoral District of Christchurch Central, hereinbefore described, and proceeding generally south-westerly up the middle of the Heathcote River and the middle of the Cashmere Stream to a point in line with the south-western boundary of part Lot 3, D.P. 12061; thence north-westerly to and along that south-western boundary and the south-western boundary of Lot 1, D.P. 17148, and along the production of the last-mentioned boundary to the middle of Cashmere Road, being a point on the generally eastern boundary of the Electoral District of Wigram, hereinbefore described; thence generally northerly along that generally eastern boundary to and generally easterly along the generally southern boundaries of the Electoral Districts of Riccarton and Christchurch Central, hereinbefore described, to the point of commencement.

#### LYTTELTON

ALL that piece bounded by a line commencing at a point on the mean high-water mark of the sea at the south-eastern corner of the Electoral District of Avon hereinbefore described and proceeding generally south-easterly, southerly, and westerly along the mean high-water mark of the sea to the middle of the former outlet of Lake Ellesmere (east of Maori Reserve 878); thence north-easterly along a right line to the middle of the mouth of the Halswell River on the northern shore of Lake Ellesmere; thence northerly up the middle of the Halswell River to a point in line with the former south-eastern boundary of R.S. 1069; thence north-easterly to and along that boundary (through R.S. 37634) and its production to the middle of Park Hill Road; thence generally north-easterly along the middle of Park Hill Road and Ahuriri Bush Road South and its production to the south-western boundary of R.S. 1901; thence generally northerly along the south-western and south-eastern boundaries of R.S. 1901, the south-eastern and eastern boundaries R.S. 1863, the eastern boundaries of Lot 2 and 1, D.P. 10264, to and continuing northerly along the summit of the Port Hills to and along the eastern boundary of Reserve 3956 and its production to the northern side of Summit Road; thence generally south-westerly along the northern side of the said road and its production to and along the north-western boundary of Reserve 4069 and the south-eastern boundary of part Lot 4, D.P. 9250, to the southernmost corner of part Lot 4 aforesaid; thence generally north-westerly along the north-eastern boundary of R.S. 38518 to and along the eastern boundary of the land shown on D.P. 8208 to the middle of Early Valley Road; thence generally westerly along the middle of that road and its production to the middle of Halswell River; thence northerly up the middle of that river to the south-eastern boundary of the Electoral District of Wigram, hereinbefore described; thence generally north-easterly along that south-eastern boundary and easterly along the southern boundaries of the Electoral Districts of Sydenham, Christchurch Central, and Avon, hereinbefore described, to the point of commencement including all wharves and extensions seaward and also including the Chatham Islands.

#### RAKAIA

ALL that piece, bounded by a line commencing at the middle of the former outlet of Lake Ellesmere (east of Maori Reserve 878), being the westernmost corner of the Electoral District of Lyttelton, hereinbefore described, and proceeding south-westerly along the mean high-water mark of the sea to the middle of the Ashburton River; thence generally north-westerly up the middle of that river to the middle of the South Island Main Trunk Railway; thence north-easterly along the middle of that railway to a point in line with the south-western side of Racecourse Road; thence north-westerly to and along that roadside to the south-eastern boundary of Lot 155, D.P. 236; thence south-westerly along that boundary to the middle of Wakanui Stream; thence generally north-westerly along the middle of that stream to the south-eastern side of Allens Road; thence south-westerly along that roadside and its production to the middle of Middle Road; thence north-westerly along the middle of that road and south-westerly along the middle of Farm Road, to the intersection of the middle lines of Farm Road and Harrison Street; thence southerly along a right line to the intersection of the south-western side of Harrison Street and the south-eastern side of Farm Road; thence south-westerly along that roadside and its production to the south-western side of Alford Forest Road; thence south-easterly along that roadside to the south-eastern side of a road forming the north-western boundaries of Lots 9, 25, 26, and 27, D.P. 864; thence south-westerly along that roadside to the north-eastern boundary of Lot 41, D.P. 888; thence south-easterly along that boundary and south-westerly along the south-eastern boundaries of Lots 41 and
