42, D.P. 888, and the production of the last-mentioned boundary to the middle of the north branch of the Ashburton River; thence north-westerly up the middle of that north branch to the southern boundary of Run 119 in Block XI, Mount Somers Survey District; thence generally north-westerly along the southern and western boundaries of Run 119, the south-eastern and south-western boundaries of Run 118A, and the south-western boundary of Run 118 to the middle of Lake Stream; thence northerly down the middle of that stream to the middle of the Rakaia River, and generally westerly up the middle of that river to the middle of the Louper Stream; thence northerly up the middle of that stream to Whitcombe Pass on the summit of the Southern Alps, being a point on the south-eastern boundary of the Electoral District of West Coast, hereinbefore described; thence generally north-easterly along that south-eastern boundary, to and along the generally south-western boundary of the Electoral District of Rangiora, hereinbefore described, and the generally western boundaries of the Electoral Districts of Wigram and Lyttelton, hereinbefore described, to the point of commencement.

## South Canterbury

ALL that piece, bounded by a line commencing at Mount Hopkins on the summit of the Main Divide in Block XVI, Mueller Survey District, being a point on the south-eastern boundary of the Electoral District of West Coast, hereinbefore described, and proceeding south-westerly along the middle of the Richardson Glacier to the middle of the Hopkins River; thence generally south-easterly along the middle of that river, the general north-eastern shore of Lake Ohau, and the middle of the Ohau River to the middle of the Waitaki River; thence south-easterly down the middle of that river to a point in line with the middle of Grassy Hill Road in Block VI, Elephant Hill Survey District; thence generally north-easterly to and along the middle of that road, Elephant Hill Road, and No. 32 State Highway to the middle of the north branch of that river to a point due west of the source of Waituna Stream; thence due east to that source and down the middle of the Waituna Stream; thence due east to that source and down the middle of the Waituna Stream to the mean high-water mark of the sea; thence generally northerly along that mean high-water mark to the middle of the Pareora River; thence generally northewesterly up the middle of that river to its intersection with the middle of the Pareora Gorge Road; thence north-westerly along the middle of that road and Cannington Road to the middle of Wiseleys Road; thence generally easterly along the middle of Limestone Valley Road; thence generally south-easterly along the southern boundaries of Sections 83 and 84, Rosewill Settlement, and its production to the middle of that road, the Taiko Flat Road, Zig Zag Road, Sutherlands Road, Rural Section 37764 (closed road), Cliffs Road, and Frasers Road to a point in line with the eastern boundary of Section 115, Rosewill Settlement; thence generally northerly to and along that boundary and its production to the middle of Rolling Ridges Road; thence generally north-easterly along the middle of that road, Downs Road, Olivers Road, Keanes Road, No.

## Timaru

ALL that piece, bounded by a line commencing at the mouth of the Pareora River and proceeding generally north-westerly, north-easterly, and easterly along the boundary of the Electoral District of South Canterbury, hereinbefore described, to the mean high-water mark of the sea; thence generally south-westerly along that mean high-water mark to the point of commencement and including all wharves and other extensions seaward.

## Oamaru

All that piece, bounded by a line commencing at a point in line with the mean high-water mark of the sea in the middle of the mouth of Waituna Stream, Block XII, Waimate Survey District, being a point on the boundary of the Electoral District of South Canterbury hereinbefore described, and proceeding generally south-westerly and south-easterly along the mean high-water mark of the sea and generally south-westerly along the mean high-water mark of the Otago Harbour to a point in line with the north-eastern boundary of Section 2, Block I, Lower Harbour West Survey District; thence north-westerly to and along the north-eastern boundary of that Section 2 to the south-eastern side of the South Island Main Trunk Railway; thence south-westerly along that side of that railway to the south-western boundary of Section 2, aforesaid; thence south-easterly along that boundary of Section 2 aforesaid, to a point in line with the south-eastern side of Ocean Terrace; thence south-westerly to and along the south-eastern side of Ocean Terrace to the westernmost corner of Lot 39, Deeds Plan 57; thence south-easterly along a right line to the intersection of the southern side of Slant Street and the south-eastern side of Woodland Terrace; thence south-westerly along the south-eastern side of Woodland Terrace and its production to the north-eastern boundary of Section 4, Block II, Lower Harbour West Survey District; thence south-easterly along the north-eastern boundary of that Section 4 and its production to a point in line with the south-eastern boundary of Section 4, aforesaid; thence south-westerly to and along the south-eastern boundaries of Sections 4, 3, 2, 1, and 10, Block II, Lower Harbour West Survey District, to the north-western corner of Section 62, Sawyers Bay Survey
