

north-westerly along its south-western boundary to the southern side of a public road through Sections 73 and 75, Block V, aforesaid; thence westerly along that southern side, to and south-westerly and north-westerly along the south-eastern and south-western boundaries of Section 75, Block V, aforesaid, to the southernmost corner of Section 54, Block V, aforesaid; thence northerly along the eastern boundaries of Sections 54 and 55, Block V aforesaid, to the south-western side of a public road forming the north-eastern boundary of Section 76, Block V, aforesaid; thence south-easterly along the south-western side of that road to a point in line with the south-eastern boundary of Section 9, Block V, aforesaid; thence generally north-easterly to and along that south-eastern boundary and the south-eastern boundaries of Sections 10 and 11, Block V aforesaid, to the easternmost corner of the last-mentioned section, and along a right line to the southernmost corner of Section 3, Block V, aforesaid; thence northerly along the eastern boundary of Section 3 aforesaid, to Trig. Station S, Swampy Spur, on the southern boundary of Block III, North Harbour and Blueskin Survey District, and proceeding north-westerly along a right line to Silver Peak Trig. Station; thence north-westerly along a right line to the easternmost corner of Block VI, Silverpeak Survey District, and along the north-eastern boundary of that Block VI to the southern boundary of Block IX, Silverpeak Survey District; thence westerly and northerly along the southern and western boundaries of that Block IX, and the production of the last-mentioned boundary to the right (north-western) bank of the Three O'Clock Stream; thence generally south-westerly along that bank of that stream to its intersection with the eastern boundary of Block VIII, Silverpeak Survey District; thence north-easterly along the south-eastern boundary of that Block VIII to the south-western corner of Run 171B; thence generally northerly along the western boundaries of that Run 171B and Runs 171G and 171C to a point due east of Trig. "D" Hummock; thence due west to Trig. "D" Hummock; thence north-westerly along a right line between Trig. "D" Hummock and a point on the right (north-western) bank of the Taieri River on the production of the south-western boundary of Run 714, Strath Taieri Survey District, to its intersection with the eastern boundary of Block VII, Strath Taieri Survey District; thence generally northerly along the eastern boundary of that Block VII to a point in line with the northern boundary of Section 17, Block VII, aforesaid; thence generally westerly to and along the northern boundaries of Sections 17 and 18, Block VII aforesaid, and the production of the last-mentioned boundary to the south-eastern boundary of Section 1, Block III, Strath Taieri Survey District; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of Section 1 aforesaid, to the intersection of the last-mentioned boundary with the right line aforesaid, between Trig. Station D (Hummock) and the southernmost corner of Run 205E, Strath Taieri Survey District; thence north-westerly along that right line to the middle of the Taieri River; thence generally northerly up the middle of that river, to and generally north-easterly up the middle of the Horseburn to its source approximately 36 chains south-east of Trig. Station K (Flat Hill); thence north-westerly along a right line to the said Trig. Station K; thence due east along the southern boundary of Swinburn Survey District to the middle of McLeods Road; thence generally north-easterly along the middle of McLeods Road, being along the summit of a leading ridge, to a point 40 chains due south of the northern boundary of Section 1, Block XIII, Swinburn Survey District; thence north-easterly to and along the middle of a stream to the middle of the Shag River; thence generally north-easterly along the middle of that river to its source and along a right line to Trig. Station A (Kakanui Peak); thence generally north-westerly along the south-western boundary of Run 681 and its production to the middle of a public road along the summit of the Kakanui Mountains; thence generally north-westerly along the middle of that road to Trig. Station 1 (Mount Nobbler); thence generally north-easterly along the western boundary of Run 510 to Dansey Pass; thence generally north-westerly along the eastern boundary of Run 576 and along the eastern watershed of the Kyeburn and the southern watershed of the Otematata River to Trig. Station M (Mount Buster); thence westerly and north-westerly along the summit of the Ida and Hawkdun Ranges to the southern boundary of Gala Survey District; thence westerly along the southern boundaries of Gala and Hawkdun Survey Districts to Mount St. Bathans; thence generally northerly along the western boundaries of Runs 201F, 201E, 201G, and 201B to the westernmost corner of the last-mentioned run; thence generally south-westerly along a leading ridge through Old Man Peak to the Lindis Pass; thence generally north-westerly along the summit of the range passing through Dromedary Hill, Mount Martha, Mount Gladwish, and Mount Huxley, to Mount Strauchan on the summit of the Southern Alps, being a point on the south-eastern boundary of the Electoral District of West Coast, hereinbefore described; thence generally north-easterly along that boundary, to and generally south-easterly along the south-western boundary of the Electoral District of South Canterbury, hereinbefore described, to the point of commencement; and including all adjacent islands.
