motorway to the mean high-water mark on the right bank of the Huruhuru Creek; thence generally north-easterly and south-easterly along the mean high-water mark of the Waitemata Harbour to the point of commencement; including Herald Island and other adjacent islands and all wharves and other extensions seawards.

EAST COAST BAYS
