

of Section 98 aforesaid, and its production to the middle of a stream; thence north-westerly along the middle of that stream to a point in line with the western boundary of Lot 27, D.P. 17808; thence southerly to and along the western boundary of Lot 27 aforesaid, and the western boundaries of Lots 26, 25, 24, 23, 22, 21, 20, 19, and 18, D.P. 17808, aforesaid, the western boundary of Lot 2, D.P. 37752, and the western boundary of Lot 17, D.P. 17808, and the production of the last-mentioned boundary to the middle of Waikumete West Coast Road; thence easterly along the middle of that road to a point in line with the eastern boundary of Lot 4, Deeds Plan 269; thence generally southerly to and along that boundary, and the northern and eastern boundaries of Allotment 114, Waikomiti Parish, and the production of the last-mentioned boundary to the middle of View Road; thence westerly along the middle of that road to a point in line with the eastern boundary of Lot 4 of Allotment 15, Waikomiti Parish; thence southerly to and along the eastern boundaries of Lots 4, 3, 2, and 1 of Allotment 15 aforesaid, and the eastern boundary of Allotment 112 of the said Parish to the south-eastern corner of that Allotment; thence south-westerly along a right line bearing 220° true to the middle of Shaw Road; thence southerly along the middle of that road and generally easterly along the middle of Waitakere Scenic Drive to a point in line with the middle of Waima Road; thence westerly to and along the middle of that road to a point in line with the eastern boundary of Lot 2, D.P. 18839; thence southerly along a right line to and along that boundary to the south-eastern corner of that lot; thence north-easterly along the south-eastern boundary of Allotment 27, Waikomiti Parish, generally south-easterly along the south-western and south-eastern boundaries of Lot 1, D.P. 44159, the south-western boundary of Allotment 44, Waikomiti Parish, and its production to the middle of Brooklyn-Huia Road; thence south-westerly along the middle of that road to a point in line with the northern boundary of Lot 1, D.P. 49162; thence south-easterly along a right line crossing that lot to a point on the right bank of Little Muddy Creek at the junction of the mean high-water mark of that creek with the middle of the Waikomiti Stream; thence generally south-westerly along the mean high-water mark of the Manukau Harbour and generally north-westerly along the mean high-water mark of the Tasman Sea to the point of commencement.

NEW LYNN

ALL that piece bounded by a line commencing at a point on the left bank of the Whau River on the northern boundary of Lot 3, D.P. 11169, being part Allotment 89, Waikomiti Parish, in Block III, Titirangi Survey District, being a point on the boundary of the Electoral District of Henderson, hereinbefore described, and proceeding generally south-easterly along the left bank of the Whau River crossing the mouth of the Rewarewa Creek, to the middle of Wolverton Street; thence generally easterly and southerly along the middle of that street, Miranda Street, Blockhouse Bay Road, and its production to the mean high-water mark of the Manukau Harbour; thence generally south-westerly along that mean high-water mark to the boundary of the Electoral District of Henderson, hereinbefore described; thence generally north-easterly along that boundary to the point of commencement and including all wharves and other extensions seaward.

GREY LYNN

ALL that piece bounded by a line commencing at the intersection of the mean high-water mark of the sea and the production of the middle line of Fairlands Avenue and proceeding generally north-easterly along that mean high-water mark to a point in line with the middle of New Street; thence south-westerly to and along that street and the middle of College Hill, Ponsonby Road, Richmond Road, Cockburn Street, Dryden Street, Williamson Avenue, and south-easterly along No. 16 State Highway (Great North Road) to a point bearing 38° true from the middle of School Road at its northernmost point; thence south-westerly along that bearing and the middle of School Road, Western Springs Road, New North Road, and Argyle Street, to the middle of the Newmarket-Opua Railway; thence generally westerly along the middle of that railway to a point in line with the middle of Guardwell Street; thence north-westerly to and along that street and Monaghan Avenue to a point in line with the eastern boundary of Lot 18, D.P. 18922; thence southerly and westerly along the boundary of that Lot and the southern boundaries of Lots 17, 16, 15, D.P. 18922, 31, and 32, D.P. 38189, Lots 11, 10, 9, and 8, D.P. 18922, a right line across Grant Street, to and along the southern boundaries of Lots 7-1, D.P. 18922, the southern boundary of part Allotment 35, Titirangi Parish, comprised in C.T. 534/92, a right line across Carrington Road, and along the southern boundary of Allotment 32, Titirangi Parish, and its production to the middle of Oakley Creek; thence up the middle of that creek to a point in line with the middle of Fairlands Avenue; thence north-westerly to and along the middle of that street and its production to the point of commencement, and including all wharves and other extensions seaward.

MOUNT ALBERT

ALL that piece bounded by a line commencing at the intersection of the mean high-water mark of the sea with a line produced from the middle of Fairlands Avenue and proceeding generally easterly along the boundary of the Electoral District of Grey Lynn, hereinbefore described, and the middle of the Newmarket-Opua railway to and along the eastern boundaries of Lots 86, 87, and 88, D.P. 309, along a right line across Charles Street, to and along the eastern boundaries of Lots 85 and 79, D.P. 196, along a right line across Tawari Street to and along the western boundary of the part Lot 51, Deeds Plan 47 (blue), comprised in C.T. 569/148, and the last-mentioned boundary produced to its intersection with the southern boundary of Allotment 12, of Section 10 Suburbs of Auckland, crossing the intervening George Street West, Onslow Road, Cromwell Street, and Walters Road; thence westerly along the last-mentioned boundary, crossing the intervening Cromwell Street and Marlborough Street and continuing along the northern side of Raleigh Street to and southerly along the eastern side of Cricket Avenue to the easternmost corner of Lot 22,
