Setting Apart Land as a Maori Reservation

WHEREAS by Order in Council dated 20 March 1967 and published in *Gazette*, 30 March 1967, No. 19, p. 446, the land described in the Schedule hereto was set apart as a Maori reservation, and whereas it is necessary that the said Order in Council be cancelled upon the grounds that the land, being subject to a receivership order, was ineligible, as at date of the said Order in Council, to be set apart as a Maori reservation and whereas the receiver now having been discharged it is desired to again set apart the land as a Maori reservation; now therefore, pursuant to section 439 of the Maori Affairs Act 1953, notice is hereby given as follows.

NOTICE

1. The reservation constituted by Order in Council dated 20 March 1967 and published in *Gazette*, 30 March 1967, No. 19, page 446, relating to the land described in the Schedule hereto is hereby cancelled.

2. The land described in the Schedule hereto is hereby set apart as a Maori reservation for the purposes of a meeting place and marae for the common use and benefit of the Ngati Rangatahi, Ngati Reremai, Ngati Ngapoutama, and Ngati Hinewai tribes.
