

along the dividing ridge to a point on the eastern boundary of Section 8, Block IV, Apiti S.D., distant 4 chains from the south-eastern corner of the said section 8, along the eastern boundary of the said Section 8 and its production to and along the original southern and western sides of Te Parapara Road to a point in line with the southern boundary of Section 19, Block I, Umutoi S.D., to and along that boundary to the southernmost corner of the said Section 19, and along a right line to Trig Station O (Mangahuia) in Block II, Umutoi S.D.; thence northerly along a right line to Trig Station L (Pourangaki) in Block XIV, Ruahine S.D.; thence south-easterly along a right line to Trig Station N (Te Hekenga) and the production of that line to the summit of the Ruahine Range in Block III, Umutoi S.D.; thence generally northerly along the summit of the Ruahine Range to Trig Station Y in Block XII, Pukeokahu S.D., and along the watershed between the Rangitikei River and the Ngaruroro River and their tributaries passing through Trig Station 26 (Tawake Tohunga) in Block XII, Mangamaire S.D., to the generally southern watershed of the Waikato River and its tributaries in Block XII, Waiotaka S.D.; thence generally north-westerly, south-westerly, and westerly, along the generally southern watershed of the Waikato River and its tributaries to Trig Station D (Matihao) in Block XI, Ruapehu S.D.; thence generally northerly along right lines to Trig Station D (Ngauruhoe) in Block XVI, Tongariro S.D., to Trig Station Tongariro No. 2 in Block XII, Tongariro S.D., to Trig Station KL (Karewarewa) in Block XII, Tongariro S.D., to the south-western corner of Waimanu 2D in Block IV, Tongariro S.D., and to the south-eastern corner of Oraukura 1 in Block VIII, Puketapu S.D.; thence westerly along the southern boundaries of Oraukura 1 and 2 to the north-eastern corner of Waimanu 2C, along a right line to peg III on the eastern boundary of Waimanu Block, and along the south-eastern and southern boundaries of Waimanu Block and the northern boundary of Waione Block to Trig Station Maungaku in Block X, Maungaku S.D.; thence generally northerly along the western watershed of the Waikato River and its tributaries to and along the eastern boundary of Hurakia A in Block II, Puketapu S.D., the eastern boundaries of Hurakia A1 and Ketemaringa 2, the south-eastern boundary of Ketemaringa 1, and the south-eastern and eastern boundaries of Maraeroa Block to Trig Station Pureora; thence north-westerly along a right line to the southernmost corner of Rangitoto A31B to its intersection with the southern boundary of Lot 1, D.P. S. 8586; thence generally westerly along the southern boundary of the said Lot 1, the eastern side of No. 30 State Highway, the eastern and northern boundaries of Section 7, Block XIV, Ranginui S.D., the northern boundaries of Sections 2 and 5, Block XIV, Ranginui S.D., and the eastern boundary of Section 6, Block XIV, Ranginui S.D., to the westernmost corner of Section 11, Block XIV, Ranginui S.D.; thence generally westerly along right lines to the easternmost corner of Rangitoto Tuhua 36A2C8 and to the easternmost corner of Rangitoto Tuhua 36A2C4B, and along the north-eastern boundary of that subdivision to its northernmost corner; thence generally southerly along the north-western and south-western boundaries of Rangitoto Tuhua 36A2C4B to its southernmost corner, along a right line to and along the western boundary of Rangitoto Tuhua 36A2B1 and the north-western boundary of Rangitoto Tuhua 36A2B to the northern end of boundary line bearing 59° 35' distance 3701.8 links, and along right lines to the westernmost corner of Rangitoto Tuhua 36A1A1A and to the northernmost corner of Section 6, Block III, Pahi S.D.; thence generally south-westerly along the north-western boundary of the said Section 6, the northern and western boundaries of Section 3, Block I, Pahi S.D., the northern and western boundaries of Section 10, Block I, Pahi S.D., and along a right line across Maniaiti Road to and along the eastern boundary of section 4, Block XIV, Mapara S.D., to its south-eastern corner; thence generally north-westerly along the southern boundary of the said Section 4 to and along the middle of Tapuwa Road to a point in line with the eastern boundary of Section 2, Block XIV, Mapara S.D., to and along the eastern and northern boundaries of the said Section 2, and the eastern and northern boundaries of Rangitoto Tuhua 79F1 to its north-western corner; thence southerly along the western boundary of Rangitoto Tuhua 79F1 to its intersection with the production of the north-western boundary of Lot 2, D.P. 9455; thence generally south-westerly along that production to and along the north-western boundary of Lot 2, D.P. 9455 (including a right line across the Taumarunui - Te Kuiti Road), to the eastern side of the North Island Main Trunk Railway, and along a right line to and along the north-western boundary of Lot 1, D.P. 9455, and the generally western boundaries of Lot 1, D.P. 7475 (including a right line across Mapara Road), to Trig Station Tihikoooreo; thence south-easterly along the north-eastern boundaries of Rangitoto Tuhua 77B2B1 and 77B2B2 and generally south-westerly along the south-eastern boundary of

Rangitoto Tuhua 77B2B1 to its southernmost corner, along right lines to the westernmost corner of Rangitoto Tuhua 77B2A and to peg XVIII on the western boundary of Lot 15, D.P. 3058, along the western boundary of the said Lot 15 to and along the western and northern side of Takiri Road to a point due north of the easternmost corner of Lot 17, D.P. 3057, and along a right line to and along the south-eastern boundary of the said Lot 17 to its southernmost corner; thence generally westerly along the northern boundary of Section 7, Block VI, Tangitu S.D. (including a right line across Hiwi Road), the north-eastern boundaries of Sections 21 and 1, Block V, Tangitu S.D., the eastern boundary of Section 8, Block V, Tangitu S.D., the northern boundaries of Section 8 and Subdivision 1 of Section 8, Block V, Tangitu S.D., and along a right line across Kakara Road to and along the north-eastern boundaries of Section 9 and 6, Block VIII, Aria S.D., to the northernmost corner of the said Section 6; thence generally south-westerly along the western boundary of the said Section 6, the northern boundary of Section 7, Block VIII, Aria S.D., the north-eastern and north-western boundaries of Section 1, Block VIII, Aria S.D., the eastern and southern boundaries of Section 12, Block III, Aria S.D., the eastern side of the Ohura-Mokau Road, the north-eastern boundary of Section 4, Block VII, Aria S.D., and the north-western side of the Ohura-Mokau Road and Pirere Road to a point in line with the south-western boundary of part Section 3, Block VII, Aria S.D., as shown on S.O. Plan 8326; thence north-westerly along a right line to the south-eastern corner of Section 15, Block III, Aria S.D.; thence generally south-westerly along the south-eastern boundary of the said Section 15, the western boundary of Subdivision 1 and Section 2, Block VII, Aria S.D., the north-western boundaries of Subdivision 2 of Section 2, and Section 5, Block VII, Aria S.D., the northern boundaries of Section 9 and Subdivision 1 of Section 7, Block VI, Aria S.D., the production of the last-mentioned boundary to the middle of Waitewhena Road, along the middle of that road to a point in line with the northern boundary of Section 9, Block V, Aria S.D., and to and along the northern boundaries of Sections 9 and 13, Block V, Aria S.D., to Trig Station Tarara; thence generally southerly along the western boundaries of Sections 13 and 9, Block V, Aria S.D., Sections 1 and 2, Block IX, Aria S.D., and Sections 1 and 2, and Subdivision 2 of Section 3, Block XIII, Aria S.D., to the northern boundary of Section 2, Block I, Ohura S.D.; thence generally westerly along the northern boundary of the said Section to its north-western corner and along a right line to Trig Station Tawhitiraupaka; thence generally south-westerly along the western boundary of Section 3, Block IV, Waro S.D., to and along the south-eastern watershed of the Mohakatino and Mangaone Streams to and along the northern boundary of Section 5, Block VI, Waro S.D., to the eastern boundary of Section 9, Block VI, Waro S.D.; thence generally southerly along the eastern boundaries of Sections 9, 7, and 3, Block VI, Waro S.D. and Section 5, Block X, Waro S.D. and the production of the last-mentioned boundary to the southern side of Kotare Road, along that side to and along the eastern boundaries of Sections 5 and 15, and the eastern and southern boundaries of Section 3, Block X, Waro S.D., and the south-eastern boundary of Section 8, Block XIV, Waro S.D., to a point in line with the northern boundary of Section 4, Block XIV, Waro S.D.; thence westerly along a right line to the north-eastern corner of the said Section 4; thence generally southerly along the south-western side of Okau Road to a point in line with the southern side of Rangi Road, to and along that side, the eastern and southern boundaries of Section 6, Block XIV, Waro S.D., along a right line across Mount Dampier Road to and along the southern boundary of Section 3, Block XIV, Waro S.D., the eastern boundary of Section 13, Block II, Pouatu S.D., and its production to the southern side of Mangapapa Road, along that side to and along the western boundary of Section 7, Block II, Pouatu S.D., to and along the eastern watershed of the Waitara River to the northern boundary of Section 2, Block II, Pouatu S.D.; thence westerly along the northern boundary of the said Section 2 to and generally southerly along the eastern watershed of the Waitara River to and along the middle of Rimuputa Road adjoining Lot 1, D.P. 7178, to and along the eastern watershed of the Waitara River to the western side of Ohura Road adjoining Section 97, Block X, Pouatu S.D., and along that side, crossing Mangaowata Road, to the north-western boundary of Section 11, Block X, Pouatu S.D.; thence generally south-westerly along the north-western boundaries of Sections 11, 107, 106, and 108, and Subdivisions 1 and 2 of Section 5, and parts of Section 5, Block X, Pouatu S.D., the generally northern boundary of Section 4, Block IX, Pouatu S.D., and its production to the south-eastern side of Marco Road, along that side to and along the southern boundary of Section 9, Block IX, Pouatu S.D., the western boundaries of Sections 2S, 1S, and 3S, Marco Settlement, and Section 59, Block XIII, Pouatu S.D., the northern boundaries
