

of Section 7 and Subdivisions 1 and 2 of Section 6, Block XIII, Pouatu S.D., the production of the last-mentioned boundary to the middle of a road adjoining the northern and western boundaries of the said Subdivision 2 of Section 6, along the middle of that road to a point in line with the north-western boundary of Section 9, Block XVI, Upper Waitara S.D., and to and along that boundary to and along the south-eastern watershed of the Waitara River to the south-western boundary of Section 8, Block XVI, Upper Waitara S.D.; thence generally southerly along the south-western boundaries of Sections 8 and 11 and again, Section 8, Block XVI, Upper Waitara S.D., Sections 175 and 173, Block IV, Ngatimaru S.D., and Sections 57, 1, and 52, Block I, Mahoe S.D., along the production of the last-mentioned boundary across Ohura Road to the western boundary of Subdivision 2 of Section 19, Block I, Mahoe S.D., along that boundary to and along the western boundary of Section 3, Block V, Mahoe S.D., and its production to the middle of Arnold Road, along the middle of that road and Tirohanga Road to a point in line with the eastern boundary of Section 11, Block V, Mahoe S.D., and to and along that boundary to the southernmost corner of the said Section 11; thence generally south-easterly along the north-eastern watershed of the Mangaehu Stream to and along the eastern boundary of Lot 17, D.P. 403, and the western boundaries of Blocks X and XIV, Mahoe S.D., to and along the south-western and south-eastern boundaries of Section 8, Block XIV, Mahoe S.D., the southern boundary of Section 9, Block XIV, Mahoe S.D., the southern side of Taumata Road to a point in line with the south-western boundary of Section 6, Block XIV, Mahoe S.D., to and along that boundary to the north-eastern side of Taumata Road and along that side and the north-eastern boundary of Pahautuhia 3 to Trig Station Whakaihukawa; thence again generally south-easterly along the north-eastern boundaries of Section 1, Block III, Taurakawa S.D., and Section 9, Block II, Taurakawa S.D., and the production of the last-mentioned boundary to and along the middle of Whakaihukawa Road to a point in line with the middle of Kotekiekie Road; thence generally southerly along the western watershed of the Wanganui River to and along the south-eastern and southern boundaries of Section 6, Block VIII, Taurakawa S.D., to and along the generally western watershed of the Wanganui River to Trig Station Maungarau in Block XII, Taurakawa S.D.; thence generally south-easterly along the eastern boundary of Section 2, Block XII, Taurakawa S.D., and its production to and along the middle of Pokeka Road and Pipiriki Road to the middle of Watershed Road; thence generally southerly along the middle of Watershed Road to a point in line with the north-eastern boundary of Mangapapa 1C2A, to and along that boundary and the eastern boundaries of Mangapapa 1C2A, Lot 1, D.P. 2764, the land shown on D.P. 10533, and Lot 3, D.P. 2765 (including right lines across Watershed and Rangitatau East Roads), to Trig Station Turangapiopio No. 1 in Block XII, Moumahaki S.D.; thence again generally southerly along the generally eastern boundaries of Manganuiotahu Block (including right lines across Rangitatau East Road) to Trig Station Papanangiora in Block XVI, Moumahaki S.D.; thence westerly along the northern boundary of Section 2, Block XVI, Moumahaki S.D., to the westernmost corner of the said Section 2, and along a right line to the intersection of the middle lines of Rangitatau East Road and the road passing through Manganuiotahu Block; thence generally south-westerly along the middle of the latter road to a point in line with the north-eastern boundary of Section 11, Block XIV, Moumahaki S.D., along a right line to Trig Station Pakira, along the northern and western boundaries of Lot 5, D.P. 4789 (including a right line across Rangitatau West Road), the western boundaries of Lot 1, D.P. 20628, the southern and eastern boundaries of Lot 1, D.P. 3228, the western boundary of Lot 2, D.P. 3228, and its production to and along the middle of Rangitatau West Road and Paraka Road to a point in line with the south-eastern boundary of Lot 2, D.P. 6682, along a right line to Trig Station C and the production of that line to and along the middle line of No. 3 State Highway to a point in line with the north-western boundary of Lot 3, D.P. 17859, to and along that boundary and its production to the north-eastern side of the Marton-New Plymouth Railway, along a right line to Trig Station EE, along a right line to the angle in the south-western boundary of Section 96, Waitotara District (9829 links from the south-eastern corner of the said Section 96), and along the production of that line to the sea coast; thence south-easterly along the sea coast to the point of commencement.

#### SECOND SCHEDULE

THE AREA IN RESPECT OF WHICH SPECIAL PROVISIONS APPLY  
ALL that area in the Wellington, South Auckland, and Taranaki Land Districts comprising the City of Wanganui, the Borough of Taumarunui, the Town Districts of Ohura and Manunui, and parts of the Counties of Wanganui, Waitotara, Waimarino, Stratford, Clifton, Taumarunui, Waitomo, Otorohanga, and

Taupo, and containing 2,930 square miles, more or less, bounded by a line commencing at a point on the sea coast due west from the southernmost corner of Section 285, Left Bank Wanganui River, in Block XIII, Ikitara S.D., and proceeding due east along a right line to that corner; thence generally north-easterly along the eastern boundary of Section 285, the southern and eastern boundaries of Section 255, the southern and eastern boundaries of Section 289 (including a right line across a road), and the southern and eastern boundaries of Section 147 (including a right line across a road), Left Bank Wanganui River, along the eastern boundary of Lot 3, D.P. 27194, the southern boundary of Section 185 and the southern and eastern boundaries of Section 186, Left Bank Wanganui River, to the southern side of No. 3 State Highway, along that side to a point in line with the eastern side of Warrengate Line, and to and along that side to and along the southern side of the Wanganui-Kauangaroa Road to a point in line with the south-western boundary of Lot 10, D.P. 18301; thence generally northerly to and along the south-western boundaries of Lots 10, 4, and 11, D.P. 18301, the western boundaries of Lot 1, D.P. 18301, and Section 217, Left Bank Wanganui River, the southern boundary of Section 232 and the eastern boundaries of Sections 232, 234, 300, and 301, Left Bank Wanganui River, and the eastern boundaries of Lot 2, D.P. 8123, and Sections 302, 303, 304, and 305, Left Bank Wanganui River (including a right line across Kaukatea Road), to the north-eastern corner of the said Section 305; thence again generally northerly along the eastern boundaries of Makirikiri 2 and Sections 18, 17, 16, and 15, Pikopiko District, the eastern and northern boundaries of Lot 6, D.P. 7416, the western boundaries of Lot 1, D.P. 29324, and Lots 2 and 1, D.P. 9494, and the eastern, southern, and north-eastern boundaries of Lot 2, D.P. 7418 (including a right line across No. 4 State Highway), to the southern side of the road at the northernmost corner of the said Lot 2; thence again generally along the southern and eastern sides of that road to and along the eastern side of Parihau Road to a point in line with the north-eastern boundary of Section 8, Block IV, Waipakura S.D.; thence generally north-westerly to and along the north-eastern boundaries of sections 8, 4, and 3, Block IV, Waipakura S.D., the north-western boundary of the said Section 3 and its production to the western side of a road, and along that side to the southern boundary of Lot 6, D.P. 29357; thence generally north-easterly along that boundary, the western and northern boundaries of Lot 4, D.P. 29333, the production of the last-mentioned boundary to and along the southern boundaries of Lot 5, D.P. 29333, and Tauakira 2E, the western and generally southern boundaries of Section 1A, Block XIII, Ngamatea S.D., to the easternmost corner of the said Section 1A, and along a right line to Trig Station J (Harawira) in Block XIII, Ngamatea S.D.; thence generally north-westerly along a right line to the south-eastern corner of Lot 7, D.P. 29352, and along the southern boundaries of Lots 7, 4, and 3, D.P. 29352, the western boundary of Lot 3, D.P. 29352, the northern boundaries of Lots 2 and 1, D.P. 29352, and Lot 2, D.P. 29333, the north-eastern boundary of Lot 1, D.P. 29350, and its production to the middle of Matahiwi Track, and along the middle of that road to a point in line with the eastern boundary of Lot 2, D.P. 29336; thence northerly to and along that boundary to a point distant approximately 50 chains from its northern end; thence north-westerly along the ridge forming the watershed to its intersection with the north-western boundary of Lot 2, D.P. 29336, and south-westerly along the north-western boundaries of Lots 2 and 1, D.P. 29336, to a point distant 6,444 links from the northernmost corner of the said Lot 1; thence generally northerly along right lines to Trig Station Karewarewa and to the south-eastern corner of Lot 4, D.P. 29363, along the eastern boundary of that lot and the eastern and southern boundaries of Lot 3, D.P. 29363, the western side of Waipuna Road and the southern side of the Pipiriki-Raetihi Road to a point in line with the eastern boundary of Lot 4, D.P. 29346, to and along that boundary, the eastern and northern boundaries of Poutahi Block, and the eastern boundary of Waimarino A18 to the southern side of Mangaturoa Road; thence generally easterly along that side to a point in line with the eastern side of the road adjoining Waimarino 4, 5, and 6; thence northerly to and along that side to and generally south-easterly along the southern side of the road adjoining Waimarino A6 and passing through Waimarino A11 and adjoining and passing through Section 21, Block II, Makotuku S.D., to a point in line with the western boundary of Section 4, Block II, Makotuku S.D.; thence generally north-easterly along a right line to the south-western corner of the said Section 4, the southern and eastern boundaries of the said Section 4, the eastern boundaries of Sections 5 and 31, Block II, Makotuku S.D., the southern side of Ohura Road to a point in line with the south-eastern side of Middle Road, to and along that side to and along the north-eastern boundaries of Sections 6 and 7, Block III, Makotuku S.D., to a point in line with the south-eastern boundary of
