## NOTICE

1. This notice may be cited as the Traffic (Hamilton City) Notice No. 1, 1972.

2. The road specified in the First Schedule hereto is hereby excluded from the limitations as to speed imposed by section 52 of the Transport Act 1962.

3. The road specified in the Second Schedule hereto is hereby declared to be a 40-miles-an-hour speed limit area for the purposes of regulation 27A of the Traffic Regulations 1956\*.

4. So much of the Traffic (Hamilton City and Waikato County) Notice No. 1, 1971, dated the 23rd day of June 1971, under section 52 of the Transport Act 1962 and regulation 27A of the Traffic Regulations 1956\*, as relates to No. 3 State Highway in Hamilton City is hereby revoked.

SITUATED within Hamilton City:

No. 3 State Highway (Hamilton-Woodville via New Plymouth) (from the No. 1 State Highway (Awanui-Bluff) to a point 3 chains measured northerly generally along the said highway from Lorne Street and from the southern boundary of Hamilton City to a point 5 chains measured south-easterly along the said highway from Tomin Road).
