- (a) The power to borrow money in New Zealand;
- (b) The power to raise money in New Zealand by the issue, whether in New Zealand or elsewhere, of any shares in the company;
- (c) The power to make any call in respect of any shares issued by the company to a person ordinarily resident in New Zealand.

**3. Revocation**—The notice consenting to the issue of capital by certain life insurance offices, dated the 16th day of September 1971†, is hereby revoked.
