A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare that a water pipeline easement in gross for waterworks over the land described in the Schedule hereto is hereby taken and shall vest in the Chairman, Councillors, and Inhabitants of the County of Bay of Islands as from the date hereinafter mentioned, the full free liberty, right, licence, and authority in perpetuity for the Councill servants, agents, and workmen from time to time and at all
