*The Taranaki Polytechnic Notice 1973*

PURSUANT to section 69 of the Education Act 1964, the Minister of Education hereby gives the following notice.

## NOTICE

1. (1) This notice may be cited as the Taranaki Polytechnic Notice 1973.

(2) This notice shall come into force on the 1st day of February 1973.

2. There shall be a Board of Governors to be known as the Council of the Taranaki Polytechnic.

3. The Council of the Taranaki Polytechnic shall be constituted as follows:

- (a) Two members elected by the governing bodies of secondary schools in the Province of Taranaki;
- (b) Two members appointed by the Taranaki Local Bodies Association, one of which shall be appointed on the nomination of the New Plymouth City Council;
- (c) Two members elected by the Industrial Associations of Employers in Taranaki;
- (d) Two members elected by the Industrial Associations of Employees in Taranaki;
- (e) One member appointed by the Federated Farmers of New Zealand (Taranaki Provincial District);
