

**MATIRA ROAD EXTENSION—RAGLAN COUNTY**

IN the matter of the Public Works Act 1928.

Public notice is hereby given that the Raglan County Council proposed, under the provisions of the Public Works Act 1928, to execute a certain public work, namely, the construction of a road, and for the purposes of that public work the land described in the First Schedule hereto is required to be taken for road, and the road described in the Second Schedule hereto is required to be stopped, and the land described in the Third Schedule hereto is required to be taken for the use, convenience, or enjoyment of a road. And notice is hereby further given that the plans of the lands so required to be taken and for the portions of road required to be stopped are deposited at the offices of the Raglan County Council, Great South Road, Ngaruawahia, and there open for inspection; all persons affected by the execution of the said public work, or by the taking of the said land, or by the stopping of the said road should, if they have any objections to the execution of the said public work, or to the taking of the said land, or to the stopping of the said road, not being objections to the amount or payment of compensation, set forth the same in writing and send the written objection within 40 days of the first publication of this notice to the office of the Council; and if any objection is made in accordance with this notice a public hearing of the objection will be held, unless the objector otherwise requires, and each objector will be advised of the time and place of the hearing.
