SPECIAL ORDER

The Auckland Regional Authority, in exercise of the powers vested in it by the Auckland Regional Authority Act 1963, section 37, and in pursuance of the authority conferred upon it under the Local Authorities Loans Act 1956, and in exercise of all other powers enabling it on that behalf, doth hereby resolve by special resolution, intended to operate as a special order, to borrow the sum of three hundred and thirty-seven thousand dollars (\$337,000) as a special loan to be known as Parks and Reserves Loan No. 10, 1973, \$337,000, for the purposes of and incidental to the development of regional parks and Auckland Centennial Memorial Park.

The foregoing special order was passed at an ordinary meeting of the Auckland Regional Authority held on 17 September 1973 and confirmed at an ordinary meeting of the said Authority held on 15 October 1973, having meantime been advertised in the *Auckland Star* on 22nd September and 6 October 1973.
