RESOLUTION MAKING SPECIAL RATE
Redemption Loan 1973, \$12,500**

PURSUANT to the Local Authorities Loans Act 1956, the Onehunga Borough Council hereby resolves that, for the purpose of providing the annual charges on a loan of \$12,500 authorised to be raised under the above-mentioned Act for the repayment on maturity of that portion of the Sewer, Storm Water, and Streets Loan 1967—\$470,000 as will mature on the 8th day of April 1973, the said Onehunga Borough Council hereby makes a special rate of 0.0073c in the dollar upon the rateable value of all rateable property in the Borough of Onehunga, and that the special rate shall be an annual-recurring rate during the currency of the loan and be payable over a period of 10 years in respect to the loan or until the loan is fully paid off.
