NOTICE is hereby given that, pursuant to the authority vested in him by the Minister of Trade and Industry, the Secretary of the Department of Trade and Industry has fixed rates of payment for subsidy on sheep meats in cents per pound as follows:

With respect to claims covering the period 26 March 1973 to 8 April 1973 inclusive:
