*Relicensing the Carey Fishing Co. Ltd. to Occupy a Site for a Slipway in the Floating Basin, Westport Harbour*

(3) The premium payable by the licensee shall be six dollars (\$6) and the annual sum so payable by the licensee shall be twenty dollars (\$20); provided always that the Minister may review the annual sum payable at the end of the first year or any subsequent year of the said term.

*Price Order No. 2232 (Amendment No. 1 of Price Order No. 2189) (Spirits and Beer)*

1. This order may be cited as Price Order No. 2232 and shall be read together with and deemed part of Price Order No. 2189\* (hereinafter referred to as the principal order).

2. This order shall come into force on the 13th day of April 1973.

3. The principal order is hereby amended by revoking clause 7 of the principal order and substituting the following clause:

7. Subject to the provisions of this order, the maximum price that may be charged shall be—

(a) For each standard measure of spirits sold in public bars in premises licensed under the Sale of Liquor Act 1962.

(b) For spirits sold in public bars in the premises of any Licensing Trust, the price lawfully being charged on 12 April 1973 increased by 1 cent per nip.
