Supply Scheme as a whole.

The foregoing special orders were passed at a meeting of the Auckland Regional Authority held on 19 February 1973 and confirmed at a meeting of the said authority held on 19 March 1973, having meantime been advertised in the Auckland Star on 24 February and 7 March 1973.
