Revoking a Proclamation Defining the Middle Line of Paeroa-Pokeno Railway

DENIS BLUNDELL, Governor-General A PROCLAMATION

PURSUANT to the Public Works Act 1928, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby revoke the Proclamation dated the 15th day of April 1939 and published in *Gazette*, 20 April 1939, Vol. I, p. 1145, and deposited in the Land Registry Office as No. 9923, defining the middle line of the Paeroa-Pokeno Railway in Blocks XIV and XV, Opaheke Survey District, and in Block II, Maramarua Survey District, in so far as it affects land in the North Auckland Land District.
